4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 54, Education Code, is
6	amended by adding Section 54.0514 to read as follows:
7	Sec. 54.0514. TEMPORARY LIMITATION ON TOTAL AMOUNT OF
8	TUITION. (a) In this section, "tuition" includes:
9	(1) tuition for which the rates are prescribed by this
10	chapter; and
11	(2) tuition charged by an institution of higher
12	education under Section 54.0513 or another law authorizing an
13	institution to establish tuition rates.
14	(b) Notwithstanding Section 54.0513 or another law
15	authorizing an institution to establish tuition rates, the total
16	amount of tuition charged by an institution of higher education to a
17	student for a semester or term during the 2021-2022 or 2022-2023
18	academic year or for the 2023 fall semester may not exceed the total
19	amount of tuition that the institution would have charged under
20	this chapter to a similarly situated student for the 2020 summer
21	term or fall semester, as applicable.
22	(c) For purposes of this section, students are similarly
23	situated if they share the same residency status, degree program,
24	course load, course level, tuition exemption status, and other

1	circumstances affecting the tuition charged to the student.
2	(d) This section does not ensure that the total amount of
3	tuition charged to an individual student does not increase based on
4	a change in the student's residency status, degree program, course
5	load, course level, tuition exemption status, or other circumstance
6	affecting the tuition charged to the student.
7	(e) The Texas Higher Education Coordinating Board may adopt
8	rules as necessary to administer this section.
9	(f) This section expires December 31, 2023.
10	SECTION 2. Subchapter E, Chapter 54, Education Code, is
11	amended by adding Section 54.5002 to read as follows:
12	Sec. 54.5002. TEMPORARY LIMITATIONS ON FEE INCREASES. (a)
13	Notwithstanding any other provision of this subchapter or other
14	law, in each semester or term during the 2021-2022 and 2022-2023
15	academic years and in the 2023 fall semester, the governing board of
16	an institution of higher education may not charge a fee under this
17	subchapter in an amount that is greater than the amount of the fee
18	charged by the institution for the 2020 summer term or fall
19	semester, as applicable.
20	(b) The limitation provided by this section applies to a fee
21	even if an increase in the amount of the fee is approved by a vote of
22	the students, student government, or student fee advisory committee
23	of the institution of higher education.
24	(c) This section expires December 31, 2023.
25	SECTION 3. This Act takes effect immediately if it receives
26	a vote of two-thirds of all the members elected to each house, as
27	provided by Section 39, Article III, Texas Constitution. If this
