16	(B) will prevent the caretaker from appearing at
17	the polling place on election day.
18	Sec. 107.002. FORM AND CONTENTS OF APPLICATION. The
19	secretary of state shall prescribe a unique application for a
20	ballot to be voted under this chapter that must:
21	(1) be in the form of an affidavit; and
22	(2) include, in addition to the information required
23	by the applicable provisions of Section 84.002, a certificate of a
24	licensed physician, licensed chiropractor, or accredited Christian
