1	the municipality. The municipality by ordinance shall prescribe the
2	information to be included in the application. The governing body
3	by ordinance may authorize the establishment or use of the cemetery
4	if the municipality determines and states in the ordinance that the
5	establishment or use of the cemetery does not adversely affect
6	public health, safety, and welfare. This subsection applies only
7	to a municipality that has a population of:
8	(1) at least 55,000 and not more than 60,000 and that
9	is located in two counties, each of which has a population of less
10	<u>than 132,000; or</u>
11	(2) at least 24,000 and not more than 26,000 and that
12	is the county seat of a county that has a population of at least
13	130,000 and not more than 135,000.
14	SECTION 2. This Act takes effect immediately if it receives
15	a vote of two-thirds of all the members elected to each house, as
16	provided by Section 39, Article III, Texas Constitution. If this
17	Act does not receive the vote necessary for immediate effect, this
18	Act takes effect September 1, 2021.
