## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the establishment of the office of community violence
3	intervention and prevention within the Department of State Health
4	Services and a grant program for violence intervention and
5	prevention services.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. This Act may be cited as the Community Violence
8	Intervention and Prevention Act.
9	SECTION 2. Subtitle B, Title 2, Health and Safety Code, is
10	amended by adding Chapter 53 to read as follows:
11	CHAPTER 53. OFFICE OF COMMUNITY VIOLENCE INTERVENTION AND
12	PREVENTION
13	SUBCHAPTER A. GENERAL PROVISIONS
14	Sec. 53.001. DEFINITIONS. In this chapter:
15	(1) "Advisory committee" means the grant review
16	advisory committee established under Section 53.102.
17	(2) "Office" means the office of community violence
18	intervention and prevention established under Section 53.051.
19	Sec. 53.002. RULES. The executive commissioner shall adopt
20	rules as necessary to implement this chapter.
21	Sec. 53.003. FUNDING. The department shall solicit and
22	accept gifts, grants, and donations on behalf of the office to carry
23	out the office's duties under this chapter.

SUBCHAPTER B. OFFICE: ESTABLISHMENT, POWERS, AND DUTIES

Τ	Sec. 55.051. ESTABLISHMENT; PURPOSE. THE COMMITSSIONET
2	shall establish within the department the office of community
3	violence intervention and prevention for the purposes of:
4	(1) coordinating and expanding violence intervention
5	and prevention activities;
6	(2) reducing the incidence of interpersonal violence
7	and homicide;
8	(3) providing leadership, coordination, and technical
9	assistance to promote effective state and local efforts on reducing
10	preventable injuries and deaths resulting from all forms of

18	Sec. 53.052. POWERS AND DUTIES. (a) The office shall
19	develop collaborative relationships with state agencies involved
20	in reducing interpersonal violence, including:
21	(1) child abuse;
22	(2) elder abuse;
23	(3) violence involving youth;
24	(4) family violence;
25	(5) intimate partner violence;
26	(6) gun violence;
27	(7) sexual assault; and

1	(8) violence against an individual based on the
2	<pre>individual's actual or perceived:</pre>
3	(A) sexual orientation;
4	(B) gender identity; or
5	(C) gender expression.
6	(b) To fulfill the purposes of this chapter, the office
7	shall:
8	(1) integrate violence intervention and prevention
9	education into state-funded substance use programs;
10	(2) support the development and implementation of
11	comprehensive, community-based violence intervention and
12	prevention initiatives throughout this state, including
13	initiatives focused on preventing the types of violence described
14	by Subsection (a);
15	(3) develop and recommend comprehensive wraparound
16	and other support services, including interpersonal violence and
17	suicide prevention programs, that are funded by local governmental
18	entities; and
19	(4) assist local organizations that provide violence
20	intervention and prevention services in seeking and applying for a
21	grant under Subchapter C.
22	(c) The office shall develop and implement a public health
23	strategy for implementing the purposes described by Section 53.051,
24	which must include:
25	(1) the use of culturally competent, community-wide
26	risk assessment tools;
27	(2) the use of methods to identify individuals in need

- 2 services;
- 3 (3) the provision of cognitive and family-based
- 4 counseling;
- 5 (4) the coordination of available services to prevent
- 6 incidents of violence; and
- 7 (5) as appropriate, technical assistance from
- 8 culturally competent organizations or individuals.
- 9 Sec. 53.053. INCREASING PUBLIC AWARENESS OF VIOLENCE;
- 10 DIRECTORY OF VIOLENCE INTERVENTION AND PREVENTION SERVICES. (a)
- 11 The office shall conduct a statewide public health campaign on the
- 12 impact of violence, strategies to help stop violence from
- 13 occurring, and the use of alternative dispute resolution methods
- 14 for addressing incidents of violence.
- 15 (b) The office shall develop and post on the department's
- 16 <u>Internet website a directory of violence intervention and</u>
- 17 prevention services available in each county in this state.
- 18 SUBCHAPTER C. COMMUNITY VIOLENCE INTERVENTION AND PREVENTION GRANT
- 19 PROGRAM
- Sec. 53.101. ESTABLISHMENT AND ADMINISTRATION OF GRANT
- 21 PROGRAM. The office shall establish and administer a community
- 22 <u>violence intervention and prevention grant program and award grants</u>
- 23 under the program to improve public health and safety by supporting
- 24 effective violence reduction strategies in communities throughout
- 25 this state that are disproportionately impacted by a high incidence
- 26 of violence, including:
- 27 <u>(1) gun violence;</u>

         Sec. 53.102. ADVISORY COMMITTEE. (a) The office shall

   establish the grant review advisory committee to assist the office

   in reviewing and selecting grant applications for a grant award.
   The advisory committee must include:

         Sec. 53.103. ELIGIBILITY AND APPLICATION REQUIREMENTS. (a)

   The office, with advice from the advisory committee, shall award

- 2 (b) To be awarded a grant under this subchapter, a county,
- 3 municipality, or community-based organization shall submit to the
- 4 office, in the form and manner prescribed by the office, a complete
- 5 application that includes a statement describing:
- 6 (1) the community issues or concerns for which the
- 7 grant money is sought;
- 8 (2) the applicant's goals and objectives for use of the
- 9 grant money, including the applicant's plan for implementing an
- 10 evidence-based violence reduction initiative using the grant
- 11 money; and
- 12 (3) the applicant's plan to enhance local coordination
- 13 of existing violence intervention and prevention programs and
- 14 minimize the duplication of services.
- 15 (c) If appropriate to address regional problems or provide a
- 16 more comprehensive solution:
- 17 (1) a county or municipality may submit a joint
- 18 application with one or more other counties or municipalities; and
- 19 (2) a community-based organization may submit a joint
- 20 application with one or more other community-based organizations.
- Sec. 53.104. REVIEW AND SELECTION OF GRANT APPLICANTS. (a)
- 22 The office, with assistance and advice from the advisory committee,
- 23 shall review grant applications submitted under this subchapter and
- 24 select the applicants for grant awards.
- 25 (b) In selecting applicants to be awarded a grant, the
- 26 office shall give preference to applicants whose proposals
- 27 <u>demonstrate:</u>

(1) the greatest likelihood for reducing violence in 1 the community served by the applicant without contributing to the 2 3 mass incarceration of individuals; 4 (2) for a joint application that includes at least one 5 community-based organization, a partnership with one or more entities, including another community-based organization or a 6 7 public entity; 8 (3) leadership that reflects the demographics of the community where the grant money will be used; 9 (4) experience with formerly incarcerated individuals 10 or individuals who are otherwise involved in the criminal justice 11 12 system; and (5) experience with individuals who are experiencing 13 14 or have experienced interpersonal violence. 15 Sec. 53.105. REQUIRED USE OF GRANT MONEY. (a) A grant recipient shall use a grant awarded under this subchapter to 16 17 support, expand, or replicate evidence-based violence reduction initiatives focused on interrupting cycles of violence, 18 19 victimization, and retaliation to reduce the incidence of firearm violence, including: 20 21 (1) hospital-based violence intervention programs; 2.2 (2) community outreach programs; and 23 (3) initiatives with focused deterrence strategies. 24 (b) The office may award a grant under this subchapter only in accordance with a contract between the office and the grant 25

recipient. The contract must include provisions affording the

office sufficient control to ensure the public purpose of

- 5 (c) Subject to Subsection (b), a county or municipal
- 6 recipient of a grant awarded under this subchapter must distribute
- 7 not less than 50 percent of the grant money in this state to one or
- 8 more of the following:
- 9 (1) a community-based organization;
- 10 (2) an Indian tribe or tribal organizations; or
- 11 (3) a public entity whose primary focus is community
- 12 safety or gun violence prevention.
- 13 Sec. 53.106. REPORTING REQUIREMENTS. Each grant recipient
- 14 shall report to the office, in a form and at intervals prescribed by
- 15 the office, the recipient's progress toward achieving the grant
- 16 <u>objectives.</u>
- 17 Sec. 53.107. EFFICACY EVALUATION OF GRANT PROGRAM. The
- 18 office may contract with an independent entity with expertise in
- 19 evaluating community-based, grant-funded programs to evaluate the
- 20 effectiveness of the grant program under this subchapter, provided
- 21 that, in conducting the evaluation, the entity uses:
- 22 (1) both qualitative and quantitative methods, as
- 23 appropriate; and
- 24 (2) participatory action research methods or other
- 25 research methods that incorporate subject engagement, to the extent
- 26 practicable.
- 27 SECTION 3. Not later than December 1, 2021:

- 1 (1) the commissioner of state health services shall
- 2 establish the office of community violence intervention and
- 3 prevention within the Department of State Health Services as
- 4 required by Chapter 53, Health and Safety Code, as added by this
- 5 Act; and
- 6 (2) the executive commissioner of the Health and Human
- 7 Services Commission shall adopt the rules necessary to implement
- 8 Chapter 53, Health and Safety Code, as added by this Act.
- 9 SECTION 4. This Act takes effect September 1, 2021.
