## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the composition of districts for the election of
- 3 members of the United States House of Representatives.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The purpose of this Act is to fulfill the
- 6 legislature's duty to redraw the districts for the election of the
- 7 members of the United States House of Representatives elected from
- 8 this state in compliance with the United States and Texas
- 9 Constitutions and applicable federal law following the publication
- 10 of the 2020 federal decennial census and the decennial
- 11 reapportionment of representative districts among the states.
- 12 SECTION 2. The districts from which the members of the
- 13 United States House of Representatives are elected are the
- 14 districts as provided by law and used for the election of the
- 15 members of the House of Representatives of the 117th Congress of the
- 16 United States except as those districts are changed by Section 3 of
- 17 this Act.
- 18 SECTION 3. (a) Angelina County is transferred from
- 19 Congressional District 1 to Congressional District 8.
- 20 (b) Gillespie County is transferred from Congressional
- 21 District 21 to Congressional District 11.
- (c) The portion of Congressional District 19 located in
- 23 Floyd County is transferred to Congressional District 13.
- 24 (d) Bexar County Precinct 4036 is transferred from

- 1 Congressional District 23 to Congressional District 35.
- 2 SECTION 4. In this Act, "tract," "block group," and "block"
- 3 mean the geographic areas identified by those terms on the 2010
- 4 Census TIGER/Line Shapefiles, prepared by the federal Bureau of the
- 5 Census for the Twenty-third Decennial Census of the United States,
- 6 enumerated as of April 1, 2010.
- 7 SECTION 5. It is the intention of the Texas Legislature
- 8 that, if any county, tract, block group, block, or other geographic
- 9 area has erroneously been left out of this Act, a court reviewing
- 10 this Act should include that area in the appropriate district in
- 11 accordance with the intent of the legislature, using any available
- 12 evidence of that intent, including evidence such as that used by the
- 13 Supreme Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W.
- 14 749 (1922).
- SECTION 6. (a) This Act supersedes all previous enactments
- 16 or orders adopting districts for the United States House of
- 17 Representatives. All previous acts of the legislature adopting
- 18 districts for the United States House of Representatives are
- 19 repealed.
- 20 (b) Chapter 3 (S.B. 4), Acts of the 83rd Legislature, 1st
- 21 Called Session, 2013, is repealed.
- 22 SECTION 7. The districts established in this Act apply to
- 23 the election of the members of the United States House of
- 24 Representatives beginning with the primary and general elections in
- 25 2022 for members of the 118th Congress of the United States. This
- 26 Act does not affect the membership or districts of the United States
- 27 House of Representatives for the 117th Congress of the United

- 1 States.
- 2 SECTION 8. This Act takes effect immediately if it receives
- 3 a vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution. If this
- 5 Act does not receive the vote necessary for immediate effect, this
- 6 Act takes effect September 1, 2021.
