- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. DEFINITIONS. In this Act:
- 7 (1) "Commission" means the Health and Human Services
- 8 Commission.
- 9 (2) "Executive commissioner" means the executive
- 10 commissioner of the commission.
- 11 (3) "Medicaid" means the medical assistance program
- 12 established under Chapter 32, Human Resources Code.
- 13 (4) "Work group" means the work group established
- 14 under Section 2 of this Act.
- 15 SECTION 2. WORK GROUP ON IMPROVING TEXAS MEDICAID PROVIDER
- 16 PROCEDURES MANUAL PROVISIONS RELATING TO DENTAL SERVICES. (a) The
- 17 executive commissioner shall establish a work group for the purpose
- 18 of providing recommendations to improve the Texas Medicaid Provider
- 19 Procedures Manual in a manner that prevents the incidence of fraud,
- 20 waste, or abuse in the provision of Medicaid dental services.
- 21 (b) The executive commissioner shall appoint the members of
- 22 the work group, which must include:
- 23 (1) a representative of the commission;
- 24 (2) the dental director appointed under Section

- 1 531.02114, Government Code;
- 2 (3) a representative of the commission's office of
- 3 inspector general;
- 4 (4) at least one stakeholder to represent each of the
- 5 following interests:
- 6 (A) managed care organizations that contract
- 7 with the commission to provide Medicaid dental services;
- 8 (B) providers of Medicaid dental services; and
- 9 (C) dental academia; and
- 10 (5) additional stakeholders or other persons the
- 11 executive commissioner determines appropriate.
- 12 (c) The commission shall provide administrative support to
- 13 the work group.
- 14 (d) The executive commissioner shall appoint a member of the
- 15 work group to serve as the presiding officer.
- 16 (e) The work group shall meet at the call of the presiding
- 17 officer.
- 18 (f) The work group shall:
- 19 (1) review all provisions in the Texas Medicaid
- 20 Provider Procedures Manual related to the provision of dental
- 21 services;
- 22 (2) determine which provisions can be eliminated or
- 23 changed to prevent fraud, waste, or abuse in the provision of dental
- 24 services, including changes related to the use of dental procedure
- 25 codes by providers; and
- 26 (3) make recommendations to the executive
- 27 commissioner for improving the Texas Medicaid Provider Procedures

- 3 SECTION 3. REPORT. Not later than December 31, 2022, the
- 4 work group shall submit a report on the work group's
- 5 recommendations to the executive commissioner.
- 6 SECTION 4. ACTION ON REPORT. On receiving the work group's
- 7 recommendations, the executive commissioner shall:
- 8 (1) consider immediately adopting the recommendations
- 9 of the work group that do not require legislative action; and
- 10 (2) if implementation of a recommendation requires
- 11 legislative action, submit to the legislature a copy of the report
- 12 described by Section 3 of this Act together with the executive
- 13 commissioner's recommendations for any legislative action.
- 14 SECTION 5. ABOLISHMENT OF WORK GROUP; EXPIRATION. On
- 15 January 1, 2023:
- 16 (1) the work group is abolished; and
- 17 (2) this Act expires.
- 18 SECTION 6. FEDERAL AUTHORIZATION. If before implementing
- 19 any provision of this Act a state agency determines that a waiver or
- 20 authorization from a federal agency is necessary for implementation
- 21 of that provision, the agency affected by the provision shall
- 22 request the waiver or authorization and may delay implementing that
- 23 provision until the waiver or authorization is granted.
- 24 SECTION 7. EFFECTIVE DATE. This Act takes effect September
- 25 1, 2021.
