15	(2) a claimant's request for policy information
16	forwarded under Section 542.142.
17	(b) An insurer described by Subsection (a) shall provide to

19	(1) a sworn statement of an officer or claims manager
20	of the insurer that contains the following information for each
21	policy known by the insurer that provides or may provide relevant
22	coverage, including excess or umbrella coverage:
23	(A) the name of the insurer;
24	(B) the name of each insured;

1 (C) the limits of liability coverage; and 2 (D) any policy or coverage defense the insurer 3 reasonably believes is available to the insurer at the time the sworn statement is made; and 4 5 (2) a copy of each policy described by Subdivision (1) under which the insurer provides coverage. 6 7 (c) An insurer that fails to comply with this section is subject to an administrative penalty under Chapter 84 of not more 8 9 than \$500. 10 Sec. 542.142. DISCLOSURE BY POLICYHOLDER. (a) This section applies to a policyholder that receives a written request 11 12 for policy information from a claimant asserting a claim against the policyholder that the policyholder believes is or may be 13 covered under liability insurance coverage provided to the 14 15 policyholder. (b) A policyholder described by Subsection (a) shall 16 17 promptly: 18 (1) disclose to the claimant the name of and type of 19 coverage provided by each insurer that provides or may provide liability coverage for the claim; and 20 21 (2) forward the claimant's request to each insurer

- 2 is aware of a material change that affects a fact stated in the
- 3 <u>insurer's sworn statement under Section 542.141 or a policyholder</u>
- 4 that is aware of a material change that affects a fact stated in the
- 5 policyholder's disclosure under Section 542.142 shall provide to
- 6 the claimant a written amended statement or disclosure, as
- 7 applicable, stating the material change.
- 8 <u>(b) An amended statement provided by an insurer under</u>
- 9 Subsection (a) must be sworn and include a copy of each insurance
- 10 policy relevant to the change.
- 11 (c) The insurer or the policyholder must provide the amended
