- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 305.007, Government Code, is amended to
- 5 read as follows:
- 6 Sec. 305.007. FILING DATES FOR SUPPLEMENTAL REPORTS. (a)
- 7 The registrant must file the report required by Section 305.006 not
- 8 later than [between] the 1st [and 10th] day of each month. Subject
- 9 to Section 305.0071, the report must cover the activities occurring
- 10 during the previous month.
- 11 (b) A person who made expenditures on the registrant's
- 12 behalf that are required to be reported under Section 305.006 or a
- 13 person who has other information that is required to be reported by
- 14 the registrant under this chapter shall provide a full, verified
- 15 account of the expenditures to the registrant not later than the
- 16 [seventh day before the] date on which the registrant's report is
- 17 due.
- SECTION 2. Section 305.0071(a), Government Code, is amended
- 19 to read as follows:
- 20 (a) Except as provided by this <u>section</u>, [section:
- [(1)] an expenditure is not required to be included in a
- 22 report under Section 305.006 for a month before the month in which
- 23 the amount is readily determinable by the person making the
- 24 expenditure [+ and

- 1 [(2) an expenditure is not required to be included in a
- 2 report under Section 305.0063 for a calendar year before the year in
- 3 which the amount is readily determinable by the person making the
- 4 expenditure].
- 5 SECTION 3. Section 305.009, Government Code, is amended by
- 6 adding Subsection (f) to read as follows:
- 7 (f) Not later than the 15th day of each month, the
- 8 commission shall make available on its website the information
- 9 included in a report:
- 10 (1) filed under Section 305.006; and
- 11 (2) covering activities occurring in the previous
- 12 month.
- 13 SECTION 4. Section 305.0063, Government Code, is repealed.
- SECTION 5. The changes in law made by this Act apply only to
- 15 a report required to be filed under Section 305.006, Government
- 16 Code, on or after January 1, 2022. A report required to be filed
- 17 under Section 305.006, Government Code, before January 1, 2022, is
- 18 governed by the law in effect immediately before the effective date
- 19 of this Act, and the former law is continued in effect for that
- 20 purpose.
- 21 SECTION 6. The repeal by this Act of Section 305.0063,
- 22 Government Code, does not affect an election to file an activities
- 23 report under that section that is made before the effective date of
- 24 this Act. An election to file an activities report under former
- 25 Section 305.0063, Government Code, that is made before the
- 26 effective date of this Act is governed by the law in effect on the
- 27 date the election was made, and the former law is continued in
