4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter F, Chapter 2054, Government Code, is
6	amended by adding Section 2054.1126 to read as follows:
7	Sec. 2054.1126. SECURITY BREACH BY STATE AGENCY CONTRACTOR;
8	DEBARMENT; CIVIL PENALTY. (a) In this section:
9	(1) "Breach of system security" has the meaning
10	assigned by Section 521.053, Business & Commerce Code.
11	(2) "Sensitive personal information" has the meaning
12	assigned by Section 521.002, Business & Commerce Code.
13	(b) A state agency that owns, licenses, or maintains
14	computerized data that includes sensitive personal information,
15	confidential information, or information the disclosure of which is
16	regulated by law may sell that data to a contractor only if the sale
17	is authorized under other law and the sale contract includes a
18	statement that the contractor:
19	(1) will comply with the notification requirements of
20	Section 521.053, Business & Commerce Code;
21	(2) will notify the state agency not later than 48
22	hours after the discovery of the breach of system security,
23	suspected breach of system security, or unauthorized exposure;
24	(3) will assist each person whose personal information

No. 1743 1 was exposed with: 2 (A) protecting the person from identity theft; 3 and 4 (B) protecting or restoring the person's credit 5 rating; 6 (4) will pay any civil penalty assessed against the 7 contractor; and 8 (5) acknowledges that the contractor's failure to comply with this section: 9 10 (A) constitutes a default of the contract on notice from the state agency; and 11 12 (B) may subject the contractor to debarment from 13 contracting with the state. 14 (c) A state agency that determines a contractor has not 15 complied with this section shall refer the matter to the comptroller for action. The comptroller shall bar the contractor 16 17 from contracting with the state using procedures prescribed under Section 2155.077. Debarment under this subsection expires on the 18 19 third anniversary of the date of the debarment. (d) A contractor who obtains from a state agency 20 computerized data that includes sensitive personal information, 21 confidential information, or information the disclosure of which is 22 23 regulated by law is liable to this state for a civil penalty imposed 24 in accordance with Section 521.151, Business & Commerce Code, for a breach of system security or an unauthorized exposure of that 25 26 information. 27 SECTION 2. Section 2054.1126, Government Code, as added by

2 after the effective date of this Act.

3 SECTION 3. This Act takes effect September 1, 2021.
