c.S.H.B. No. 1754 subject to the requirements of Section 38.353 or 51.91941, Education Code, as applicable, has a supply of unissued student identification cards that do not comply with the applicable requirements of those sections, the public school or public institution of higher education may issue those student identification cards until the supply of cards is depleted.

(b) Sections 38.353 and 51.91941, Education Code, as added by this Act, apply only to an initial or replacement student identification card issued on or after June 1, 2022.
