- 3 railroad grade crossings when on-track equipment is approaching.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 545.001, Transportation Code, is amended
- 6 to read as follows:
- 7 Sec. 545.001. DEFINITIONS. In this chapter:
- 8 (1) "On-track equipment" means any car, rolling stock,
- 9 equipment, or other device that, alone or coupled to another
- 10 device, is operated on a railroad track.
- 11 (2) "Pass" or "passing" used in reference to a vehicle
- 12 means to overtake and proceed past another vehicle moving in the
- 13 same direction as the passing vehicle or to attempt that maneuver.
- 14 (3)  $[\frac{(2)}{2}]$  "School bus" includes a multifunction
- 15 school activity bus.
- SECTION 2. The heading to Section 545.251, Transportation
- 17 Code, is amended to read as follows:
- 18 Sec. 545.251. OBEDIENCE TO SIGNAL INDICATING APPROACH OF
- 19 TRAIN OR OTHER ON-TRACK EQUIPMENT.
- 20 SECTION 3. Sections 545.251(a), (c), and (e),
- 21 Transportation Code, are amended to read as follows:
- 22 (a) An operator approaching a railroad grade crossing shall
- $23\,$  stop not closer than  $15\,$  feet or farther than  $50\,$  feet from the
- 24 nearest rail if:

- 1 (1) a clearly visible railroad signal warns of the
- 2 approach of a railroad train or other on-track equipment;
- 3 (2) a crossing gate is lowered, or a flagger warns of
- 4 the approach or passage of a train or other on-track equipment;
- 5 (3) a railroad engine or other on-track equipment
- 6 approaching within approximately 1,500 feet of the highway crossing
- 7 emits a signal audible from that distance and the engine or other
- 8 equipment is an immediate hazard because of its speed or proximity
- 9 to the crossing;
- 10 (4) an approaching railroad train <u>or other on-track</u>
- 11 <u>equipment</u> is plainly visible to the operator and is in hazardous
- 12 proximity to the crossing; or
- 13 (5) the operator is required to stop by:
- 14 (A) other law;
- 15 (B) a rule adopted under a statute;
- 16 (C) an official traffic-control device; or
- 17 (D) a traffic-control signal.
- 18 (c) An operator of a vehicle who approaches a railroad grade
- 19 crossing equipped with railroad crossbuck signs without automatic,
- 20 electric, or mechanical signal devices, crossing gates, or a
- 21 flagger warning of the approach or passage of a train or other
- 22 on-track equipment shall yield the right-of-way to a train or other
- 23 on-track equipment in hazardous proximity to the crossing, and
- 24 proceed at a speed that is reasonable for the existing conditions.
- 25 If required for safety, the operator shall stop at a clearly marked
- 26 stop line before the grade crossing or, if no stop line exists, not
- 27 closer than 15 feet or farther than 50 feet from the nearest rail.

- 1 (e) In a prosecution under this section, proof that at the
- 2 time of the offense a train or other on-track equipment was in
- 3 hazardous proximity to the crossing and that the train  $\underline{\text{or other}}$
- 4 equipment was plainly visible to the operator is prima facie
- 5 evidence that it was not safe for the operator to proceed.
- 6 SECTION 4. Section 545.253(a), Transportation Code, is
- 7 amended to read as follows:
- 8 (a) Except as provided by Subsection (c), the operator of a
- 9 motor bus carrying passengers for hire, before crossing a railroad
- 10 grade crossing:
- 11 (1) shall stop the vehicle not closer than 15 feet or
- 12 farther than 50 feet from the nearest rail of the railroad;
- 13 (2) while stopped, shall listen and look in both
- 14 directions along the track for an approaching train or other
- 15 <u>on-track equipment</u> and signals indicating the approach of a train
- 16 or other on-track equipment; and
- 17 (3) may not proceed until it is safe to do so.
- SECTION 5. Section 545.2535(a), Transportation Code, is
- 19 amended to read as follows:
- 20 (a) Except as provided by Subsection (c), the operator of a
- 21 school bus, before crossing a track at a railroad grade crossing:
- 22 (1) shall stop the vehicle not closer than 15 feet or
- 23 farther than 50 feet from the track;
- 24 (2) while stopped, shall listen and look in both
- 25 directions along the track for an approaching train or other
- 26 on-track equipment and signals indicating the approach of a train
- 27 or other on-track equipment; and

- 1 (3) may not proceed until it is safe to do so.
- 2 SECTION 6. Sections 545.254(a), (b), and (c),
- 3 Transportation Code, are amended to read as follows:
- 4 (a) Before crossing a railroad grade crossing, an operator
- 5 of a vehicle that has an explosive substance or flammable liquid as
- 6 the vehicle's principal cargo and that is moving at a speed of more
- 7 than 20 miles per hour:
- 8 (1) shall reduce the speed of the vehicle to 20 miles
- 9 per hour or less before coming within 200 feet of the nearest rail
- 10 of the railroad;
- 11 (2) shall listen and look in both directions along the
- 12 track for an approaching train or other on-track equipment and for
- 13 signals indicating the approach of a train or other on-track
- 14 equipment; and
- 15 (3) may not proceed until the operator determines that
- 16 the course is clear.
- 17 (b) The operator of a vehicle that has an explosive
- 18 substance or flammable liquid as the vehicle's principal cargo,
- 19 before crossing a railroad grade crossing on a highway in a
- 20 municipality:
- 21 (1) shall stop the vehicle not closer than 15 feet or
- 22 farther than 50 feet from the nearest rail of the railroad;
- 23 (2) while stopped, shall listen and look in both
- 24 directions along the track for an approaching train or other
- 25 on-track equipment and for signals indicating the approach of a
- 26 train or other on-track equipment; and
- 27 (3) may not proceed until the operator determines that

- 1 the course is clear.
- 2 (c) Subsections (a) and (b) do not apply:
- 3 (1) if a police officer, crossing flagger, or
- 4 traffic-control signal directs traffic to proceed;
- 5 (2) where a railroad flashing signal is installed and
- 6 does not indicate an approaching train or other on-track equipment;
- 7 (3) to an abandoned or exempted grade crossing that is
- 8 clearly marked by or with the consent of the state, if the markings
- 9 can be read from the operator's location;
- 10 (4) at a streetcar crossing in a business or
- 11 residential district of a municipality; or
- 12 (5) to a railroad track used exclusively for
- 13 industrial switching purposes in a business district.
- 14 SECTION 7. Sections 545.255(c) and (d), Transportation
- 15 Code, are amended to read as follows:
- 16 (c) To move a vehicle or equipment on or across a track at a
- 17 railroad grade crossing, the operator:
- 18 (1) shall stop the vehicle or equipment not closer
- 19 than 15 feet or farther than 50 feet from the nearest rail of the
- 20 railroad;
- 21 (2) while stopped, shall listen and look in both
- 22 directions along the track for an approaching train or other
- 23 on-track equipment and for signals indicating the approach of a
- 24 train or other on-track equipment; and
- 25 (3) may not proceed until it is safe to cross the
- 26 track.
- 27 (d) An operator of a vehicle or equipment may not cross a

- 1 railroad grade crossing when warning of the immediate approach of a
- 2 railroad car $_{\underline{\prime}}$  [ $_{\underline{or}}$ ] train $_{\underline{\prime}}$  or other on-track equipment is given by
- 3 automatic signal, crossing gates, a flagger, or otherwise. If a
- 4 flagger is provided by the railroad, the operator shall move the
- 5 vehicle or equipment over the crossing at the flagger's direction.
- 6 SECTION 8. This Act takes effect September 1, 2021.
