- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 ARTICLE 1. ENTITIES GIVEN 2023 SUNSET DATE
- 6 SECTION 1.01. PUBLIC UTILITY COMMISSION OF TEXAS. Section
- 7 12.005, Utilities Code, is amended to read as follows:
- 8 Sec. 12.005. APPLICATION OF SUNSET ACT. The Public Utility
- 9 Commission of Texas is subject to Chapter 325, Government Code
- 10 (Texas Sunset Act). Unless continued in existence as provided by
- 11 that chapter or by Chapter 39, the commission is abolished and this
- 12 title expires September 1, <u>2023</u> [2025].
- 13 SECTION 1.02. OFFICE OF PUBLIC UTILITY COUNSEL. Section
- 14 13.002, Utilities Code, is amended to read as follows:
- 15 Sec. 13.002. APPLICATION OF SUNSET ACT. The Office of
- 16 Public Utility Counsel is subject to Chapter 325, Government Code
- 17 (Texas Sunset Act). Unless continued in existence as provided by
- 18 that chapter, the office is abolished and this chapter expires
- 19 September 1, 2023 [2025].
- 20 ARTICLE 2. ENTITIES GIVEN 2025 SUNSET DATE
- 21 SECTION 2.01. TEXAS ECONOMIC DEVELOPMENT AND TOURISM
- 22 OFFICE. Section 481.003, Government Code, is amended to read as
- 23 follows:
- 24 Sec. 481.003. SUNSET PROVISION. The Texas Economic

- 12 SECTION 2.03. TEXAS DEPARTMENT OF INSURANCE AND DIVISION OF
- 13 WORKERS' COMPENSATION, TEXAS DEPARTMENT OF INSURANCE. Section
- 14 31.004, Insurance Code, is amended to read as follows:
- Sec. 31.004. SUNSET PROVISION. (a) The Texas Department
- 16 of Insurance is subject to Chapter 325, Government Code (Texas
- 17 Sunset Act). Unless continued in existence as provided by that
- 18 chapter, the department is abolished September 1, 2025 [2023].
- 19 (b) Unless continued as provided by Chapter 325, Government
- 20 Code, the duties of the division of workers' compensation of the
- 21 Texas Department of Insurance under Title 5, Labor Code, expire
- 22 September 1, 2025 [$\frac{2023}{}$], or another date designated by the

- 24 SECTION 2.04. OFFICE OF PUBLIC INSURANCE COUNSEL. Section
- 25 501.003, Insurance Code, is amended to read as follows:
- Sec. 501.003. SUNSET PROVISION. The office is subject to

- 3 SECTION 2.05. OFFICE OF INJURED EMPLOYEE COUNSEL. Section
- 4 404.003, Labor Code, is amended to read as follows:
- 5 Sec. 404.003. SUNSET PROVISION. The office of injured
- 6 employee counsel is subject to Chapter 325, Government Code (Texas
- 7 Sunset Act). Unless continued in existence as provided by that
- 8 chapter, the office is abolished and this chapter expires September
- 9 1, 2025 [2023].
- 10 ARTICLE 3. ENTITIES GIVEN 2029 SUNSET DATE
- 11 SECTION 3.01. STATE BOARD OF VETERINARY MEDICAL
- 12 EXAMINERS. (a) Section 801.003, Occupations Code, is amended to
- 13 read as follows:
- 14 Sec. 801.003. APPLICATION OF SUNSET ACT. The State Board
- 15 of Veterinary Medical Examiners is subject to Chapter 325,
- 16 Government Code (Texas Sunset Act). Unless continued in existence
- 17 as provided by that chapter, the board is abolished and this chapter
- 18 expires September 1, 2029 [2021].
- 19 (b) The Sunset Advisory Commission shall conduct a
- 20 special-purpose review of the State Board of Veterinary Medical
- 21 Examiners for the 88th Legislature. In conducting the
- 22 special-purpose review under this subsection:
- 23 (1) the Sunset Advisory Commission staff evaluation
- 24 and report must be limited to reviewing the implementation of the
- 25 State Board of Veterinary Medical Examiners' database system and
- 26 the board's processes and procedures for collecting and analyzing
- 27 data as recommended by the commission to the 87th Legislature; and

- 1 (2) the commission's recommendations to the 88th
- 2 Legislature may include any recommendation the commission
- 3 considers appropriate based on the special-purpose review.
- 4 (c) The state auditor shall conduct an effectiveness audit
- 5 of the State Board of Veterinary Medical Examiners to evaluate:
- 6 (1) the board's implementation of the data-related
- 7 recommendations made in the report on the board submitted by the
- 8 Sunset Advisory Commission to the 85th Legislature and identified
- 9 as not fully implemented in the report on the board submitted by the
- 10 commission to the 87th Legislature; and
- 11 (2) any additional recommendation made in the Sunset

- 14 (d) The state auditor may not begin the audit required by

- 19 (e) The state auditor shall include the auditor's duties

- 23 ARTICLE 4. ENTITIES GIVEN 2031 SUNSET DATE
- 24 SECTION 4.01. TEXAS REAL ESTATE COMMISSION. Section
- 25 1101.006, Occupations Code, is amended to read as follows:
- Sec. 1101.006. APPLICATION OF SUNSET ACT. The Texas Real
- 27 Estate Commission is subject to Chapter 325, Government Code (Texas

- 5 ARTICLE 5. ENTITIES REMOVED FROM SUNSET REVIEW
- 6 SECTION 5.01. TEXAS LOW-LEVEL RADIOACTIVE WASTE DISPOSAL
- 7 COMPACT COMMISSION. Section 403.0054, Health and Safety Code, is
- 8 repealed.
- 9 ARTICLE 6. SUNSET REVIEW PROCESS
- 10 SECTION 6.01. REMOTE MEETINGS. Chapter 325, Government
- 11 Code, is amended by adding Sections 325.0091 and 325.0092 to read as
- 12 follows:
- 13 Sec. 325.0091. MEETINGS USING TELECOMMUNICATION DEVICES.
- 14 (a) As an exception to Chapter 551 and other law, if a meeting is
- 15 <u>located in Austin and the presiding officers of the commission are</u>
- 16 physically present at the meeting, then any number of the other
- 17 members and employees of the commission may participate in the
- 18 meeting by use of telephone conference call, video conference call,
- 19 or other similar telecommunication device.
- 20 (b) A member attending a meeting using a telecommunication
- 21 <u>device authorized by Subsection (a) is considered to be attending</u>
- 22 the meeting for purposes of constituting a quorum, for purposes of
- 23 voting, and for any other purpose allowing a member of the
- 24 commission to otherwise fully participate in the meeting.
- (c) A meeting held by use of telephone conference call,
- 26 video conference call, or other similar telecommunication device:
- 27 (1) is subject to the notice requirements applicable

- 1 to other meetings;
- 2 (2) must specify in the notice of the meeting the
- 3 location in Austin of the meeting at which the presiding officers
- 4 will be physically present;
- 5 (3) must be open to the public and shall be audible to
- 6 the public at the location in Austin specified in the notice of the
- 7 meeting as the location of the meeting at which the presiding
- 8 officers will be physically present; and
- 9 (4) must provide two-way audio communication between
- 10 all members of the commission attending the meeting during the
- 11 entire meeting, and if the two-way audio communication link with
- 12 any member attending the meeting is disrupted at any time, the
- 13 meeting may not continue until the two-way audio communication link
- 14 is reestablished.
- 15 Sec. 325.0092. MEETINGS DURING STATE OF DISASTER OR
- 16 EMERGENCY. (a) During a state of disaster or emergency declared by
- 17 the governor the commission may limit public access to the physical
- 18 location of a commission meeting.
- 19 (b) If public access to a meeting is limited as authorized
- 20 by this section, the commission shall:
- 21 (1) broadcast the video and audio of the meeting in
- 22 real time on the commission's Internet website; and
- 23 (2) provide the following information in the notice of
- 24 the meeting:
- 25 (A) the link to the broadcast on the commission's
- 26 Internet website; and
- 27 <u>(B) a description of</u> the manner in which the

- 1 public will be able to participate in the meeting, including:
- 2 <u>(i)</u> any health and safety protocols the
- 3 commission imposes to attend the meeting; and
- 4 <u>(ii)</u> any procedures for a member of the
- 5 public to:
- (a) testify electronically or in
- 7 person at the meeting; or
- 8 (b) electronically submit public
- 9 comments without testifying.
- 10 <u>(c) If the commission invites witnesses to testify at a</u>
- 11 meeting to which public access is limited under this section, the
- 12 commission shall make a reasonable effort to invite witnesses
- 13 representing different viewpoints on the matters to be considered
- 14 at the meeting.
- 15 SECTION 6.02. PROCEDURES DURING DECLARED DISASTER. Section
- 16 325.0125(b), Government Code, is amended to read as follows:
- 17 (b) The commission may only exempt agencies that have been
- 18 inactive for a period of two years preceding the date the agency is
- 19 scheduled for abolition, [ex] that have been rendered inactive by
- 20 an action of the legislature, or that the commission determines are
- 21 unable to participate in the review due to a declared disaster.
- 22 ARTICLE 7. EFFECTIVE DATE
- 23 SECTION 7.01. EFFECTIVE DATE. This Act takes effect
- 24 immediately if it receives a vote of two-thirds of all the members
- 25 elected to each house, as provided by Section 39, Article III, Texas
- 26 Constitution. If this Act does not receive the vote necessary for
- 27 immediate effect, this Act takes effect September 1, 2021.
