2 SECTION 2. Sections 361.0905(e-1) and (e-2), Health and Safety Code, as added by this Act, apply only to an application 3 4 related to a permit for a medical waste facility that is submitted to the Texas Commission on Environmental Quality on or after the 5 6 effective date of this Act. An application related to a permit for a medical waste facility that was submitted to the Texas Commission 7 8 on Environmental Quality before the effective date of this Act is governed by the law in effect at the time the application was filed, 9 and the former law is continued in effect for that purpose. 10

SECTION 3. This Act takes effect September 1, 2021.
