5	SECTION 1. Section 74.501, Property Code, is amended by
6	amending Subsection (d) and adding Subsection (d-1) to read as
7	follows:
8	(d) On receipt of a claim form and all necessary
9	documentation and as may be appropriate under the circumstances,
10	the comptroller may approve the claim of:
11	(1) the reported owner of the property;
12	(2) if the reported owner died testate:
13	(A) the appropriate legal beneficiaries of the
14	owner as provided by the last will and testament of the owner that
15	has been accepted into probate or filed as a muniment of title; or
16	(B) the executor of the owner's last will and
17	testament who holds current letters testamentary;

- 19 (A) the legal heirs of the owner as provided by
- Sections 201.001 and 201.002, Estates Code; or 20
- 21 (B) the court-appointed administrator of the
- 22 owner's estate, if the administrator was appointed before the
- fourth anniversary of the date of the death of the owner; 23
- 24 (4) the legal heirs of the reported owner as

- 2 the county probate court or by a county judge;
- 3 (5) if the reported owner is a minor child or an adult
- 4 who has been adjudged incompetent by a court of law, the parent or
- 5 legal guardian of the child or adult;

- 7 (A) the president or chair of the board of
- 8 directors of the corporation, on behalf of the corporation; or

- 2 (d-1) A limited power of attorney described by Subsection
- 3 (d)(8) must be attested by two or more credible witnesses who are at
- 4 least 14 years of age and who subscribe their names to the power of
- 5 attorney in their own handwriting in the presence of the reported
- 6 owner or the reported owner's heirs. The signature of each
- 7 attesting witness must be notarized. Each witness shall provide to
- 8 the notary public the witness's current name, physical address,

- 11 SECTION 2. Section 74.501(e), Property Code, as amended by
- 12 Chapters 267 (S.B. 1420) and 897 (H.B. 3598), Acts of the 86th
- 13 Legislature, Regular Session, 2019, is reenacted and amended to
- 14 read as follows:
- 15 (e) Except as provided by Subsection (f) or Section 551.051,
- 16 Estates Code, the comptroller may not pay to the following persons a
- 17 claim to which this section applies:
- 18 (1) a creditor, a judgment creditor, a lienholder, or
- 19 an assignee of the reported owner or of the owner's heirs; or
- 20 (2) [a person holding a power of attorney from the
- 21 reported owner or the owner's heirs; or
- [(3)] a person attempting to make a claim on behalf of
- 23 a corporation that was previously forfeited, dissolved, or
- 24 terminated, if the comptroller finds that:
- 25 (A) the corporation was revived for the purpose
- 26 of making a claim under this section; and
- (B) the person submitting the claim was not an

- 1 authorized representative of the corporation at the time of the
- 2 corporation's forfeiture, dissolution, or termination.
- 3 SECTION 3. To the extent of any conflict, this Act prevails
- 4 over another Act of the 87th Legislature, Regular Session, 2021,
- 5 relating to nonsubstantive additions to and corrections in enacted
- 6 codes.
- SECTION 4. This Act takes effect September 1, 2021.
