- 8 SECTION 2. Section 111.001, Occupations Code, is amended by
- 9 amending Subdivisions (1) and (3) and adding Subdivision (2-a) to
- 10 read as follows:

- 11 (1) "Dentist," "health [Health] professional," and
- 12 "physician" have the meanings assigned by Section 1455.001,
- 13 Insurance Code.
- 14 (2-a) "Teledentistry dental service" means a health
- 15 care service delivered by a dentist, or a health professional
- 16 acting under the delegation and supervision of a dentist, acting
- 17 within the scope of the dentist's or health professional's license
- 18 or certification to a patient at a different physical location than
- 19 the dentist or health professional using telecommunications or
- 20 <u>information technology</u>.
- 21 (3) "Telehealth service" means a health service, other
- 22 than a telemedicine medical service or a teledentistry dental
- 23 service, delivered by a health professional licensed, certified, or
- 24 otherwise entitled to practice in this state and acting within the

- 1 scope of the health professional's license, certification, or
- 2 entitlement to a patient at a different physical location than the
- 3 health professional using telecommunications or information
- 4 technology.
- 5 SECTION 3. Section 111.002, Occupations Code, is amended to
- 6 read as follows:
- 7 Sec. 111.002. INFORMED CONSENT. (a) A treating physician,
- 8 dentist, or health professional who provides or facilitates the use
- 9 of telemedicine medical services, teledentistry dental services,
- 10 or telehealth services shall ensure that the informed consent of
- 11 the patient, or another appropriate individual authorized to make
- 12 health care treatment decisions for the patient, is obtained before
- 13 telemedicine medical services, teledentistry dental services, or
- 14 telehealth services are provided.
- 15 (b) A dentist who delegates a teledentistry dental service
- 16 shall ensure that the informed consent of the patient includes
- 17 disclosure to the patient that the dentist has delegated the
- 18 service.
- 19 SECTION 4. Section 111.003, Occupations Code, is amended to
- 20 read as follows:
- Sec. 111.003. CONFIDENTIALITY. A treating physician,
- 22 <u>dentist</u>, or health professional who provides or facilitates the use
- 23 of telemedicine medical services, teledentistry dental services,
- 24 or telehealth services shall ensure that the confidentiality of the
- 25 patient's <u>clinical</u> [<u>medical</u>] information is maintained as required
- 26 by Chapter 159, by Subchapter C, Chapter 258, or by other applicable
- 27 law.

- 1 SECTION 5. Section 111.004, Occupations Code, is amended
- 2 to read as follows:
- 3 Sec. 111.004. RULES. (a) The Texas Medical Board, in
- 4 consultation with the commissioner of insurance, as appropriate,
- 5 may adopt rules necessary to:
- 6 (1) ensure that patients using telemedicine medical
- 7 services receive appropriate, quality care;
- 8 (2) prevent abuse and fraud in the use of telemedicine
- 9 medical services, including rules relating to the filing of claims
- 10 and records required to be maintained in connection with
- 11 telemedicine medical services;
- 12 (3) ensure adequate supervision of health
- 13 professionals who are not physicians and who provide telemedicine
- 14 medical services; and
- 15 (4) establish the maximum number of health
- 16 professionals who are not physicians that a physician may supervise
- 17 through a telemedicine medical service.
- 18 (b) The State Board of Dental Examiners, in consultation
- 19 with the commissioner of insurance, as appropriate, may adopt rules
- 20 necessary to:
- 21 (1) ensure that patients using teledentistry dental
- 22 services receive appropriate, quality care;
- 23 (2) prevent abuse and fraud in the use of
- 24 teledentistry dental services, including rules relating to the
- 25 filing of claims and records required to be maintained in
- 26 <u>connection with teledentistry dental services;</u>
- 27 (3) ensure adequate supervision of health

- 1 professionals who are not dentists and who provide teledentistry
- 2 dental services under the delegation and supervision of a dentist;
- 3 and
- 4 (4) establish the maximum number of health
- 5 professionals who are not dentists that a dentist may supervise
- 6 through a teledentistry dental service.
- 7 SECTION 6. The heading to Section 111.005, Occupations
- 8 Code, is amended to read as follows:
- 9 Sec. 111.005. PRACTITIONER-PATIENT RELATIONSHIP FOR
- 10 TELEMEDICINE MEDICAL SERVICES OR TELEDENTISTRY DENTAL SERVICES.
- 11 SECTION 7. Section 111.005, Occupations Code, is amended by
- 12 amending Subsections (a) and (b) and adding Subsection (d) to read
- 13 as follows:
- 14 (a) For purposes of Section 562.056, a valid
- 15 practitioner-patient relationship is present between a
- 16 practitioner providing a telemedicine medical service or a
- 17 teledentistry dental service and a patient receiving the
- 18 [telemedicine medical] service as long as the practitioner complies
- 19 with the standard of care described in Section 111.007 and the
- 20 practitioner:
- 21 (1) has a preexisting practitioner-patient
- 22 relationship with the patient established in accordance with rules
- 23 adopted under Section 111.006;
- 24 (2) communicates, regardless of the method of
- 25 communication, with the patient pursuant to a call coverage
- 26 agreement established in accordance with:
- 27 (A) Texas Medical Board rules with a physician

- 1 requesting coverage of medical care for the patient; or
- 2 (B) State Board of Dental Examiners rules with a
- 3 dentist requesting coverage of dental care for the patient; or
- 4 (3) provides the telemedicine medical services or
- 5 teledentistry dental services through the use of one of the
- 6 following methods, as long as the practitioner complies with the
- 7 follow-up requirements in Subsection (b), and the method allows the
- 8 practitioner to have access to, and the practitioner uses, the
- 9 relevant clinical information that would be required in accordance
- 10 with the standard of care described in Section 111.007:
- 11 (A) synchronous audiovisual interaction between
- 12 the practitioner and the patient in another location;
- 13 (B) asynchronous store and forward technology,
- 14 including asynchronous store and forward technology in conjunction
- 15 with synchronous audio interaction between the practitioner and the
- 16 patient in another location, as long as the practitioner uses
- 17 clinical information from:
- 18 (i) clinically relevant photographic or
- 19 video images, including diagnostic images; or
- 20 (ii) the patient's relevant clinical
- 21 [medical] records, such as the relevant medical or dental history,
- 22 laboratory and pathology results, and prescriptive histories; or
- (C) another form of audiovisual
- 24 telecommunication technology that allows the practitioner to
- 25 comply with the standard of care described in Section 111.007.
- 26 (b) A practitioner who provides telemedicine medical
- 27 services or teledentistry dental services to a patient as described

- 2 (1) provide the patient with guidance on appropriate
- 3 follow-up care; and
- 4 (2) except as provided by Subsection (d), if the
- 5 patient consents and the patient has a primary care physician or a

- 7 regular dentist, as appropriate, within 72 hours after the
- 8 practitioner provides the services to the patient, a clinical
- 9 [medical] record or other report containing an explanation of:

- 12 (B) as authorized by the law under which the

- 20 location. A practitioner providing a treatment based on a
- 21 teledentistry dental service to which this subsection applies is
- 22 not required to comply with Subsection (b)(2) but shall, on request
- 23 of the patient, provide to the patient the record or report
- 24 described by that subdivision after the patient has completed the
- 25 treatment.
- SECTION 8. Section 111.006, Occupations Code, is amended by
- 27 adding Subsection (c) to read as follows:

- 1 (c) The State Board of Dental Examiners and the Texas State Board of Pharmacy shall jointly adopt rules that establish the 2 determination of a valid prescription in accordance with Section 3 111.005. Rules adopted under this subsection must allow for the 4 establishment of a practitioner-patient relationship by a 5 teledentistry dental service provided by a dentist to a patient in a 6 manner that complies with Section 111.005(a)(3) and must be 7 8 substantially similar to the rules adopted under Subsection (a) of this section. The State Board of Dental Examiners and the Texas 9 State Board of Pharmacy shall jointly develop and publish on each 10 respective board's Internet website responses to frequently asked 11 12 questions relating to the determination of a valid prescription issued in the course of the provision of teledentistry dental 13 14 services.
- 15 SECTION 9. Section 111.007, Occupations Code, is amended to read as follows: 16
- Sec. 111.007. STANDARD OF CARE FOR TELEMEDICINE MEDICAL 17 SERVICES, TELEDENTISTRY DENTAL SERVICES, AND TELEHEALTH SERVICES.
- 19 A health professional providing a health care service or
- procedure as a telemedicine medical service, a teledentistry dental 20
- service, or a telehealth service is subject to the standard of care 21
- that would apply to the provision of the same health care service or 22
- 23 procedure in an in-person setting.

24 An agency with regulatory authority over a health professional may not adopt rules pertaining to telemedicine medical 25 26 services, teledentistry dental services, or telehealth services that would impose a higher standard of care than the standard 27

- 2 SECTION 10. Chapter 111, Occupations Code, is amended by
- 3 adding Section 111.0075 to read as follows:
- 4 Sec. 111.0075. LICENSING FOR TELEDENTISTRY DENTAL
- 5 SERVICES. A health professional providing a health care service or
- 6 procedure as a teledentistry dental service is subject to the
- 7 licensing requirements that would apply to the provision of the
- 8 same health care service or procedure in an in-person setting.
- 9 SECTION 11. Chapter 111, Occupations Code, is amended by
- 10 adding Section 111.009 to read as follows:
- 11 Sec. 111.009. LIMITATION ON CERTAIN PRESCRIPTIONS. (a) In
- 12 this section, "controlled substance" and "prescribe" have the
- 13 meanings assigned by Section 481.002, Health and Safety Code.
- 14 (b) The State Board of Dental Examiners by rule shall
- 15 establish limits on the quantity of a controlled substance that a
- 16 dentist may prescribe to a patient as a teledentistry dental
- 17 service. The rules may not authorize a dentist to prescribe more
- 18 than a five-day supply of the controlled substance.
- 19 SECTION 12. Section 251.003, Occupations Code, is amended
- 20 by adding Subsection (d) to read as follows:
- 21 <u>(d) For purposes of this subtitle, a person located in</u>
- 22 another state practices dentistry in this state and is required to
- 23 hold a license to practice dentistry in this state if the person
- 24 through the use of any medium, including an electronic medium,
- 25 performs an act that constitutes the practice of dentistry on a
- 26 patient in this state.
- 27 SECTION 13. Chapter 254, Occupations Code, is amended by

- 1 adding Section 254.0035 to read as follows:
- 2 Sec. 254.0035. RULES REGARDING CALL COVERAGE AGREEMENTS.
- 3 The board shall adopt rules governing a call coverage agreement
- 4 between dentists.
- 5 SECTION 14. Section 258.001, Occupations Code, is amended
- 6 to read as follows:
- 7 Sec. 258.001. IMPERMISSIBLE DELEGATIONS. A dentist may not
- 8 delegate:
- 9 (1) an act to an individual who, by board order, is
- 10 prohibited from performing the act;
- 11 (2) any of the following acts to a person not licensed
- 12 as a dentist or dental hygienist:
- 13 (A) the removal of calculus, deposits, or
- 14 accretions from the natural and restored surfaces of exposed human
- 15 teeth and restorations in the human mouth;
- 16 (B) root planing or the smoothing and polishing
- 17 of roughened root surfaces or exposed human teeth; or
- 18 (C) any other act the delegation of which is
- 19 prohibited by board rule;
- 20 (3) any of the following acts to a person not licensed
- 21 as a dentist:
- 22 (A) comprehensive examination or diagnosis and
- 23 treatment planning;
- 24 (B) a surgical or cutting procedure on hard or
- 25 soft tissue;
- 26 (C) the prescription of a drug, medication, or
- 27 work authorization;

- 1 (D) the taking of an impression for a final
- 2 restoration, appliance, or prosthesis;
- 3 (E) the making of an intraoral occlusal
- 4 adjustment;
- 5 (F) direct pulp capping, pulpotomy, or any other
- 6 endodontic procedure;
- 7 (G) the final placement and intraoral adjustment
- 8 of a fixed or removable appliance; or
- 9 (H) the placement of any final restoration; or
- 10 (4) the authority to an individual to administer a
- 11 local anesthetic agent, inhalation sedative agent, parenteral
- 12 sedative agent, or general anesthetic agent, including as a
- 13 teledentistry dental service as that term is defined by Section
- 14 111.001, if the individual is not licensed as:

- 23 SECTION 15. Section 262.152, Occupations Code, is amended
- 24 to read as follows:
- Sec. 262.152. PERFORMANCE OF DELEGATED DUTIES. (a) Except
- 26 as provided by Section 262.1515, a dental hygienist shall practice
- 27 dental hygiene:

- 1 (1) in the dental office of a supervising dentist
- 2 licensed by the board; or
- 3 (2) in an alternate setting, including a nursing home,
- 4 the patient's home, a school, a hospital, a state institution, a
- 5 public health clinic, or another institution, under the supervision
- 6 of a supervising dentist.
- 7 (b) For purposes of this section, a dental hygienist who
- 8 practices dental hygiene as a teledentistry dental service, as
- 9 defined by Section 111.001, is practicing in an alternate setting
- 10 in compliance with Subsection (a)(2).
- 11 SECTION 16. Section 562.056(c), Occupations Code, is
- 12 amended to read as follows:
- 13 (c) For purposes of this section and Section 562.112, a
- 14 valid practitioner-patient relationship is present between a
- 15 practitioner providing telemedicine medical services or
- 16 teledentistry dental services and the patient receiving the
- 17 [telemedicine medical] services if the practitioner has complied
- 18 with the requirements for establishing such a relationship in
- 19 accordance with Section 111.005.
- SECTION 17. Section 531.001, Government Code, is amended by
- 21 amending Subdivision (4-d) and adding Subdivision (6-a) to read as
- 22 follows:
- 23 (4-d) "Platform" means the technology, system,
- 24 software, application, modality, or other method through which a
- 25 health professional remotely interfaces with a patient when
- 26 providing a health care service or procedure as a telemedicine
- 27 medical service, teledentistry dental service, or telehealth

- 1 service.
- 2 (6-a) "Teledentistry dental service" has the meaning
- 3 assigned by Section 111.001, Occupations Code.
- 4 SECTION 18. Section 531.0216, Government Code, is amended
- 5 to read as follows:
- 6 Sec. 531.0216. PARTICIPATION AND REIMBURSEMENT OF
- 7 TELEMEDICINE MEDICAL SERVICE PROVIDERS, TELEDENTISTRY DENTAL
- 8 SERVICE PROVIDERS, AND TELEHEALTH SERVICE PROVIDERS UNDER
- 9 MEDICAID. (a) The executive commissioner by rule shall develop and
- 10 implement a system to reimburse providers of services under
- 11 Medicaid for services performed using telemedicine medical
- 12 services, teledentistry dental services, or telehealth services.
- 13 (c) The commission shall encourage health care providers
- 14 and health care facilities to provide telemedicine medical
- 15 services, teledentistry dental services, and telehealth services
- 16 in the health care delivery system. The commission may not require
- 17 that a service be provided to a patient through telemedicine
- 18 medical services, teledentistry dental services, or telehealth
- 19 services.
- 20 (c-1) The commission shall explore opportunities to
- 21 increase STAR Health program providers' use of telemedicine medical

- 23 (g) The commission shall ensure that a Medicaid managed care
- 24 organization:
- 25 (1) does not deny reimbursement for a covered health
- 26 care service or procedure delivered by a health care provider with
- 27 whom the managed care organization contracts to a Medicaid

- 1 recipient as a telemedicine medical service, a teledentistry dental
- 2 <u>service</u>, or a telehealth service solely because the covered service
- 3 or procedure is not provided through an in-person consultation;
- 4 (2) does not limit, deny, or reduce reimbursement for
- 5 a covered health care service or procedure delivered by a health
- 6 care provider with whom the managed care organization contracts to
- 7 a Medicaid recipient as a telemedicine medical service, a
- 8 <u>teledentistry dental service</u>, or a telehealth service based on the
- 9 health care provider's choice of platform for providing the health
- 10 care service or procedure; and
- 11 (3) ensures that the use of telemedicine medical
- 12 services, teledentistry dental services, or telehealth services
- 13 promotes and supports patient-centered medical homes by allowing a
- 14 Medicaid recipient to receive a telemedicine medical service,
- 15 <u>teledentistry dental service</u>, or telehealth service from a provider
- 16 other than the recipient's primary care physician or provider,
- 17 except as provided by Section 531.0217(c-4), only if:
- 18 (A) the telemedicine medical service,
- 19 <u>teledentistry dental service</u>, or telehealth service is provided in
- 20 accordance with the law and contract requirements applicable to the
- 21 provision of the same health care service in an in-person setting,
- 22 including requirements regarding care coordination; and
- 23 (B) the provider of the telemedicine medical
- 24 service, teledentistry dental service, or telehealth service gives
- 25 notice to the Medicaid recipient's primary care physician or
- 26 provider regarding the [telemedicine medical service or
- 27 telehealth] service, including a summary of the service, exam

- 1 findings, a list of prescribed or administered medications, and
- 2 patient instructions, for the purpose of sharing medical
- 3 information, provided that the recipient has a primary care
- 4 physician or provider and the recipient or, if appropriate, the
- 5 recipient's parent or legal guardian, consents to the notice.
- (h) The commission shall develop, document, and implement a monitoring process to ensure that a Medicaid managed care organization ensures that the use of telemedicine medical services, teledentistry dental services, or telehealth services promotes and supports patient-centered medical homes and care coordination in accordance with Subsection (g)(3). The process must include
- 12 monitoring of the rate at which a telemedicine medical service $\underline{\, , \,}$
- 13 <u>teledentistry dental service</u>, or telehealth service provider gives
- 14 notice in accordance with Subsection (g)(3)(B).
- 15 (i) The executive commissioner by rule shall ensure that a
- 16 <u>federally-qualified</u> [federally qualified] health center as defined
- 17 by 42 U.S.C. Section 1396d(1)(2)(B) may be reimbursed for the
- 18 originating site facility fee or the distant site practitioner fee
- 19 or both, as appropriate, for a covered telemedicine medical
- 20 service, teledentistry dental service, or telehealth service
- 21 delivered by a health care provider to a Medicaid recipient. The
- 22 commission is required to implement this subsection only if the
- 23 legislature appropriates money specifically for that purpose. If
- 24 the legislature does not appropriate money specifically for that
- 25 purpose, the commission may, but is not required to, implement this
- 26 subsection using other money available to the commission for that
- 27 purpose.

- (j) In complying with state and federal requirements to provide access to medically necessary services under the Medicaid managed care program, a Medicaid managed care organization determining whether reimbursement for a telemedicine medical service, teledentistry dental service, or telehealth service is appropriate shall continue to consider other factors, including whether reimbursement is cost-effective and whether the provision of the service is clinically effective.
- 9 SECTION 19. The heading to Section 531.02162, Government 10 Code, is amended to read as follows:
- 11 Sec. 531.02162. MEDICAID SERVICES PROVIDED THROUGH
 12 TELEMEDICINE MEDICAL SERVICES, TELEDENTISTRY DENTAL SERVICES, AND
 13 TELEHEALTH SERVICES TO CHILDREN WITH SPECIAL HEALTH CARE NEEDS.
- SECTION 20. Sections 531.02162(b) and (c), Government Code, are amended to read as follows:
- (b) The executive commissioner by rule shall establish policies that permit reimbursement under Medicaid and the child health plan program for services provided through telemedicine medical services, teledentistry dental services, and telehealth services to children with special health care needs.
- 21 (c) The policies required under this section must:
- 22 (1) be designed to:
- (A) prevent unnecessary travel and encourage efficient use of telemedicine medical services, teledentistry dental services, and telehealth services for children with special health care needs in all suitable circumstances; and
- 27 (B) ensure in a cost-effective manner the

- 1 availability to a child with special health care needs of services
- 2 appropriately performed using telemedicine medical services,
- 3 teledentistry dental services, and telehealth services that are
- 4 comparable to the same types of services available to that child

- 7 (2) provide for reimbursement of multiple providers of
- 8 different services who participate in a single session of
- 9 telemedicine medical services, teledentistry dental services,

- 12 commission determines that reimbursing each provider for the
- 13 session is cost-effective in comparison to the costs that would be

- 17 lodging and other direct costs.
- 18 SECTION 21. Subchapter B, Chapter 531, Government Code, is
- 19 amended by adding Section 531.02172 to read as follows:
- Sec. 531.02172. REIMBURSEMENT FOR TELEDENTISTRY DENTAL
- 21 SERVICES. (a) The commission by rule shall require each health and
- 22 human services agency that administers a part of the Medicaid
- 23 program to provide Medicaid reimbursement for teledentistry dental
- 24 services provided by a dentist licensed to practice dentistry in
- 25 this state.
- 26 (b) The commission shall require reimbursement for a
- 27 teledentistry dental service at the same rate as the Medicaid

- 1 program reimburses for the same in-person dental service. A
- 2 request for reimbursement may not be denied solely because an
- 3 in-person dental service between a dentist and a patient did not
- 4 occur. The commission may not limit a dentist's choice of platform
- 5 for providing a teledentistry dental service by requiring that the
- 6 dentist use a particular platform to receive reimbursement for the
- 7 service.
- 8 <u>(c) The State Board of Dental Examiners, in consultation</u>
- 9 with the commission and the commission's office of inspector
- 10 general, as appropriate, may adopt rules as necessary to:
- 11 (1) ensure that appropriate care, including quality of
