A BILL TO BE ENTITLED 1 AN ACT 2 relating to polling places in a precinct. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 43.001, Election Code, is amended to 4 5 read as follows: Sec. 43.001. 6 NUMBER OF [ONE] POLLING PLACES [PLACE] IN EACH 7 PRECINCT. (a) Except as provided by this section, each [Each] election precinct established for an election shall be served by a 8 9 single polling place located within the boundary of the precinct. 10 (b) In a county with a population of more than 500,000, each election precinct established for an election may be served by more 11 than one polling place if: 12 13 (1) each polling place is located within the boundary 14 of the precinct; and (2) consideration is given to population density in 15 16 selecting the location of each polling place, so that each polling place serves approximately the same number of voters. 17 SECTION 2. Sections 43.002(a) and (b), Election Code, are 18 amended to read as follows: 19 20 For a general or special election in which the use of (a) county election precincts is required, the county clerk shall 21 recommend the location of the polling place or places for each 22 23 county election precinct, except as provided by Subsection (b). The commissioners court shall designate the recommended location as 24

1 <u>a</u> [the] polling place unless the court finds good cause to reject 2 the recommendation. In that case, the commissioners court shall 3 designate another location.

4 (b) If county election precincts are consolidated, the
5 commissioners court shall designate the location of the polling
6 place <u>or places</u> for the consolidated precinct.

7 SECTION 3. Section 43.003, Election Code, is amended to 8 read as follows:

9 Sec. 43.003. DESIGNATION OF LOCATION: PRIMARY ELECTION. 10 The county chair of a political party holding a primary election 11 shall designate the location of the polling place <u>or places</u> for each 12 election precinct in the primary unless the precinct is one that is 13 consolidated. In that case, the county executive committee shall 14 designate the location or locations.

15 SECTION 4. Section 43.004(a), Election Code, is amended to 16 read as follows:

(a) The governing body of each political subdivision
authorized to hold elections, other than a county, shall designate
the location of the polling place <u>or places</u> for each of its election
precincts.

21 SECTION 5. Section 43.005, Election Code, is amended to 22 read as follows:

23 Sec. 43.005. DESIGNATION OF LOCATION: CERTAIN SPECIAL 24 ELECTIONS. The authority establishing election precincts under 25 Section 42.062 shall designate the location of the polling place <u>or</u> 26 <u>places</u> for each precinct.

SECTION 6. This Act takes effect September 1, 2021.
