- 5 SECTION 1. Chapter 2158, Government Code, is amended by
- 6 adding Subchapter I to read as follows:
- 7 SUBCHAPTER I. PURCHASE OF UNITED STATES FLAG OR STATE FLAG
- 8 Sec. 2158.501. FLAG PROCUREMENT BY STATE AGENCY. (a) In
- 9 this subchapter, "state agency" means:
- 10 (1) a department, commission, board, office, or other
- 11 agency in the executive branch created by the constitution or a
- 12 statute of this state;
- 13 (2) the supreme court, the court of criminal appeals,
- 14 a court of appeals, or the Texas Judicial Council; or
- 15 (3) a university system or an institution of higher
- 16 education as defined by Section 61.003, Education Code.
- 17 (b) For each United States flag or Texas state flag
- 18 purchased by a state agency, the agency must:
- 19 (1) give first preference to flags manufactured in
- 20 this state using materials grown, produced, or manufactured in this

- 2 Code, is amended by adding Section 271.909 to read as follows:

- 4 In this section, "governmental agency" has the meaning assigned by
- 5 Section 271.003.
- 6 (b) For each United States flag or Texas state flag
- 7 purchased by a governmental agency, the agency must:
- 8 <u>(1) give first preference to flags manufactured in</u>
- 9 this state using materials grown, produced, or manufactured in this
- 10 state to the extent reasonable and practicable; and
- 11 (2) give second preference to flags manufactured in
- 12 this state or the United States using materials grown, produced, or
- 13 manufactured in the United States.
- 14 SECTION 3. Section 2158.501, Government Code, and Section
- 15 271.909, Local Government Code, as added by this Act, apply only to
- 16 the purchase of a United States flag or Texas flag made or a
- 17 contract for the purchase of a United States flag or Texas flag
- 18 entered into on or after the effective date of this Act.
- 19 SECTION 4. This Act takes effect September 1, 2021.
