- 2 relating to a study by the Texas Department of Transportation on the
- 3 impact of certain classifications of motor vehicle on the roads and
- 4 bridges of this state.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. DEFINITION. In this Act, "department" means the
- 7 Texas Department of Transportation.
- 8 SECTION 2. STUDY AND REPORT. (a) The department, in
- 9 consultation with the Texas A&M Transportation Institute, The
- 10 University of Texas Center for Transportation Research, and
- 11 transportation industry representatives, shall conduct a study on
- 12 the impact on the roads and bridges of this state by motor vehicles
- 13 classified as:
- 14 (1) passenger vehicles;
- 15 (2) commercial motor vehicles; and
- 16 (3) oversize or overweight vehicles.
- 17 (b) The study shall determine, for each classification of
- 18 vehicle listed in Subsection (a) of this section:
- 19 (1) the number of vehicles that drive on the roads and
- 20 bridges of this state each year;
- 21 (2) the number of miles driven on the roads and bridges
- 22 of this state each year;
- 23 (3) the total revenue contribution from taxes and fees
- 24 to the construction and maintenance of the roads and bridges of this

- 1 state;
- 2 (4) the financial impact due to costs associated with:
- 3 (A) construction and maintenance of the roads and
- 4 bridges of this state; and
- 5 (B) congestion on the roads and bridges of this
- 6 state; and
- 7 (5) whether and by what amount the total revenue
- 8 contribution determined under Subdivision (3) of this subsection
- 9 exceeds or falls short of the financial impact determined under
- 10 Subdivision (4) of this subsection.
- 11 (c) The study shall assess the overall economic benefits to
- 12 the economy of this state of:
- 13 (1) commercial motor vehicles; and
- 14 (2) oversize or overweight vehicles.
- 15 (d) The study shall recommend one or more changes to
- 16 existing tax or fee structures to ensure that vehicles of each
- 17 classification listed under Subsection (a) of this section
- 18 contribute revenue to fund the construction and maintenance of the
- 19 roads and bridges of this state in an amount at least equal to the
- 20 financial impact of the vehicles of that classification on those
- 21 roads and bridges. The recommendations shall include:
- 22 (1) specific dollar amounts for taxes and fees for
- 23 each classification of vehicle; and
- 24 (2) if applicable, new methods of structuring existing
- 25 sources of revenue.
- 26 (e) Not later than December 1, 2022, the department shall
- 27 submit to the governor, the lieutenant governor, and the

- 1 legislature a written report on the findings of the study. The
- 2 report must include recommendations for policy and statutory
- 3 changes, including any proposed legislation, that are based on the
- 4 results of the study.
- 5 SECTION 3. EXPIRATION. This Act expires May 1, 2023.
- 6 SECTION 4. EFFECTIVE DATE. This Act takes effect
- 7 immediately if it receives a vote of two-thirds of all the members
- 8 elected to each house, as provided by Section 39, Article III, Texas
- 9 Constitution. If this Act does not receive the vote necessary for
- 10 immediate effect, this Act takes effect September 1, 2021.
