A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to a study on incorporating fine arts into the foundation
- 3 curriculum for public schools.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. STUDY ON FINE ARTS AS FOUNDATION CURRICULUM
- 6 COURSE. (a) The commissioner of education shall establish a task
- 7 force to study the utility, efficacy, and feasibility of
- 8 incorporating fine arts into the foundation curriculum under
- 9 Section 28.002(a)(1), Education Code, in public schools in this
- 10 state.
- 11 (b) The commissioner of education shall appoint members of
- 12 the task force. The task force must include at least:
- 13 (1) one fine arts public school educator;
- 14 (2) one fine arts public school administrator;
- 15 (3) one principal at a fine arts-integrated public
- 16 school;
- 17 (4) one representative from the State Board of
- 18 Education;
- 19 (5) one representative from a fine arts advocacy
- 20 nonprofit organization; and
- 21 (6) one parent of or person standing in parental
- 22 relation to a public school student in this state.
- 23 (c) The task force shall prepare a written report that
- 24 includes:

- 1 (1) a description of the activities of the task force;
- 2 (2) an analysis of incorporating fine arts into the
- 3 foundation curriculum, including the impact on:
- 4 (A) curriculum decisions at the district and
- 5 campus level, including evaluating the number of fine arts course
- 6 offerings available to students;
- 7 (B) the need for infrastructure support,
- 8 including additional administrative leadership, to incorporate
- 9 fine arts into the foundation curriculum and ensure the fidelity of
- 10 curriculum implementation;
- 11 (C) educator staffing, training, and
- 12 certifications needed at the district and campus level to
- 13 facilitate effective teaching of the essential knowledge and skills
- 14 for fine arts at each grade level;
- 15 (D) funding and budgetary resources at the
- 16 district and campus level needed to support educator staffing,
- 17 professional development, classroom resources, assessment
- 18 implementation, and administrative support for the fine arts
- 19 curriculum;
- 20 (E) student academic achievement at campuses at
- 21 which fine arts is treated as a foundation subject, including
- 22 evaluating academic achievement for fine arts magnet schools and
- 23 academies and fine arts-integrated campuses;
- 24 (F) college and career readiness of public school
- 25 students; and
- 26 (G) accountability for fine arts courses taught
- 27 in public schools;

- 1 (3) recommendations for legislative or other action;
- 2 and
- 3 (4) any other matters the task force considers
- 4 appropriate.
- 5 (d) Not later than September 1, 2022, the task force shall
- 6 submit the written report to the governor, lieutenant governor,
- 7 legislature, and commissioner of education.
- 8 SECTION 2. EXPIRATION. This Act expires September 1, 2023.
- 9 SECTION 3. EFFECTIVE DATE. This Act takes effect September
- 10 1, 2021.
