In this chapter, "declared 8 9 disaster" means a disaster declared by: (1) the governor under Chapter 418; or 10 (2) the president of the United States under the 11 12 Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. Section 5121 et seq.), if any part of this state is named in 13 14 the federally declared disaster area. Sec. 509A.002. ADVISORY BOARD. (a) An advisory board is 15 16 established to provide the department with recommendations for the emergency response plan developed under Section 509A.003 and to 17 update those recommendations annually. 18 (b) The advisory board is composed of: 19 20 (1) the executive director or the executive director's 21 designee; 22 (2) the commissioner of public health of the 23 Department of State Health Services or the commissioner's designee; 24 and

(f) Chapter 2110 does not apply to the composition or 13 14 duration of the advisory board. 15 Sec. 509A.003. EMERGENCY RESPONSE PLAN. (a) The department shall develop an emergency response plan to be 16 17 implemented when responding to a declared disaster.

18 (b) The emergency response plan must specify the operating 19 procedures that will be implemented by a correctional facility 20 during a declared disaster, including:

21 (1) evacuation procedures for inmates and employees of 22 <u>the facility;</u>

23 (2) guidelines for employees of the facility to ensure 24 <u>their safety and well-being; and</u> 25 (3) provisions to:

26 (A) prevent or minimize extended lockdowns or 27 periods of inmate segregation in a correctional facility;

1 (B) ensure that an inmate may continue to participate, during any extended period of a declared disaster, in 2 3 any classes or programs that the Board of Pardons and Paroles has required the inmate to complete before being released on parole; 4 5 (C) ensure that inmates have commissary access at regular intervals during any extended period of a declared 6 7 disaster; (D) ensure that the department and each 8 correctional facility have sufficient quantities of personal 9 10 protective equipment for employees and inmates; 11 (E) ensure that an inmate is not denied access to 12 medical care, medication, or personal hygiene items; and (F) prohibit a correctional facility from 13 14 suspending in-person inmate visitation during any extended period 15 of a declared disaster, provided that a correctional facility may temporarily institute video visitation for the health and safety of 16 17 inmates and staff. SECTION 2. The Texas Department of Criminal Justice shall 18 19 develop the emergency response plan required by Section 509A.003, Government Code, as added by this Act, not later than the 180th day 20 after the date the advisory board submits recommendations to the 21
