- (b) A school district that elects to use a writing portfolio assessment under this section shall design the assessment in consultation with a public or private institution of higher education and submit the assessment to the agency for approval. The agency shall approve the assessment if the assessment is:
- 20 (1) determined by the public or private institution of 21 higher education that consulted on the design of the assessment to 22 be valid and reliable; and
- 23 (2) designed to assess:
- 24 (A) a student's mastery of the essential

- 1 knowledge and skills in writing through timed writing samples;
- 2 (B) improvement of a student's writing skills
