20	(3) polishes exposed human teeth, restorations in the
21	human mouth, or roughened root surfaces;
22	(4) topically applies drugs to the surface tissues of
23	the human mouth or the exposed surface of human teeth;
24	(5) makes dental x-rays; [and]
25	(6) <u>administers</u> intraoral block or infiltration
26	anesthesia under the authorization and direct supervision of a

- 1 (7) performs any other service, task, or procedure
- 2 prescribed by board rule.
- 3 SECTION 3. (a) Not later than January 1, 2022, the State
- 4 Board of Dental Examiners shall:
- 5 (1) prescribe by rule the requirements for a course to
- 6 train dental hygienists to administer local anesthetic agents; and
- 7 (2) develop a procedure for the approval of courses
- 8 described by Subdivision (1) of this subsection.
- 9 (b) A rule adopted under Subsection (a) of this section must
- 10 require that a course be offered in a classroom setting at an
- 11 educational institution accredited by the Commission on Dental
- 12 Accreditation of the American Dental Association.
- SECTION 4. This Act takes effect September 1, 2021.
