- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 1102.001(1), (5), and (7), Occupations
- 6 Code, are amended to read as follows:
- 7 (1) "Apprentice inspector" means a person who is in
- 8 training under the direct supervision of a professional inspector
- 9 [or a real estate inspector] to become qualified to perform real
- 10 estate inspections.
- 11 (5) "Qualifying ["Core"] real estate inspection
- 12 course" means an educational course approved by the commission that
- 13 relates to real estate inspection, including a course on structural
- 14 items, electrical items, mechanical systems, plumbing systems,
- 15 roofing, business, law, standards of practice, report writing,
- 16 appliances, or ethics.
- 17 (7) "License" means an apprentice inspector license[τ
- 18 real estate inspector license, or professional inspector license.
- 19 SECTION 2. Section 1102.101, Occupations Code, is amended
- 20 to read as follows:
- Sec. 1102.101. APPRENTICE INSPECTOR LICENSE REQUIRED. A
- 22 person may not act or attempt to act as an apprentice inspector in
- 23 this state for a buyer or seller of real property unless the person:
- 24 (1) holds an apprentice inspector license under this

- 23 SECTION 4. Section 1102.109, Occupations Code, is amended

- Sec. 1102.109. ELIGIBILITY FOR PROFESSIONAL INSPECTOR
- 26 LICENSE. To be eligible for a professional inspector license, an
- 27 applicant must:

- 1 (1) at the time of application have:
- 2 (A) held <u>an apprentice</u> [a real estate] inspector
- 3 license for at least 12 months; and
- 4 (B) performed at least 175 real estate
- 5 inspections under indirect supervision;
- 6 (2) submit evidence satisfactory to the commission of
- 7 successful completion of at least 120 [40] classroom hours of
- 8 qualifying [core] real estate inspection courses[, in addition to
- 9 the hours required by Section 1102.108];
- 10 (3) demonstrate competence based on the examination
- 11 under Subchapter D; and
- 12 (4) satisfy the commission as to the applicant's
- 13 honesty, trustworthiness, integrity, and competence.
- 14 SECTION 5. Section 1102.111, Occupations Code, is amended
- 15 to read as follows:
- Sec. 1102.111. SUBSTITUTE REQUIREMENTS. (a) The

- 7 SECTION 6. Section 1102.113, Occupations Code, is amended
- 8 to read as follows:
- 9 Sec. 1102.113. ELIGIBILITY AS SPONSOR. A professional
- 10 inspector may sponsor an apprentice inspector [or a real estate
- 11 inspector only if the professional inspector provides sufficient
- 12 proof to the commission that the professional inspector has
- 13 completed at least 200 real estate inspections as a professional
- 14 inspector.
- SECTION 7. Section 1102.151(a), Occupations Code, is
- 16 amended to read as follows:
- 17 (a) A license examination must evaluate competence in the
- 18 subject matter of each required qualifying [core] real estate
- 19 inspection course.
- SECTION 8. Section 1102.205(b), Occupations Code, is
- 21 amended to read as follows:
- 22 (b) As a prerequisite for renewal of a [real estate
- 23 $\frac{\text{inspector}}{\text{license}_{\tau}}$] professional inspector license[$_{\tau}$] or
- 24 apprentice inspector license, the inspector must participate in the
- 25 continuing education program and submit evidence satisfactory to
- 26 the commission of successful completion of at least 16 classroom
- 27 hours of qualifying [core] real estate inspection courses or

- 3 SECTION 9. Section 1102.251, Occupations Code, is amended
- 4 to read as follows:
- 5 Sec. 1102.251. FEES. The commission shall charge and
- 6 collect reasonable and necessary fees to cover the cost of
- 7 administering this chapter for:
- 8 (1) filing an original application for an apprentice
- 9 inspector license;
- 10 (2) [filing an original application for a real estate
- 11 inspector license;
- 12 $\left[\frac{(3)}{3}\right]$ filing an original application for a
- 13 professional inspector license;
- 14 (3) [(4)] renewal of an apprentice inspector license;
- 15 (4) [(5) renewal of a real estate inspector license;
- 16 [(6)] renewal of a professional inspector license;

- (6) $[\frac{(8)}{(8)}]$ a request to change a place of business or to

- 3 SECTION 11. Subchapter I, Chapter 1102, Occupations Code,
- 4 is amended by adding Section 1102.409 to read as follows:
- 5 Sec. 1102.409. REAPPLICATION AFTER LICENSE REVOCATION,
- 6 DENIAL, OR SURRENDER. A person who has had the person's license
- 7 issued under this chapter revoked or application for a license
- 8 under this chapter denied after a hearing conducted under Section
- 9 1101.657 or who has surrendered the person's license issued under
- 10 this chapter to the commission may not reapply to the commission for
- 11 <u>a license under this chapter before the second anniversary of the</u>
- 12 date of the revocation, denial, or surrender.
- 13 SECTION 12. The following provisions of the Occupations
- 14 Code are repealed:
- 15 (1) Section 1102.001(10);

- 19 SECTION 13. Section 1102.109, Occupations Code, as amended
- 20 by this Act, applies only to an application for a professional
- 21 inspector license submitted on or after September 1, 2021. An
- 22 application submitted before September 1, 2021, is governed by the
- 23 law in effect on the date the application was submitted, and the
- 24 former law is continued in effect for that purpose.
- SECTION 14. Section 1102.409, Occupations Code, as added by
- 26 this Act, applies only to a person who has the person's license
- 27 revoked or application for a license denied or who surrenders the

- 1 person's license on or after September 1, 2021. A revocation,
- 2 denial, or surrender that occurs before September 1, 2021, is
- 3 governed by the law in effect on the date of the revocation, denial,
- 4 or surrender, and the former law is continued in effect for that
- 5 purpose.
- 6 SECTION 15. (a) Notwithstanding the repeal by this Act of
- 7 Section 1102.102, Occupations Code, a real estate inspector license
- 8 for which an application was submitted before September 1, 2021,
- 9 and that was issued under that former section before September 1,
- 10 2022, continues to be valid until the license expires and may be
- 11 renewed in accordance with the renewal requirements for that
- 12 license under Section 1102.203, Occupations Code, as those
- 13 requirements existed immediately before September 1, 2021, and the
- 14 former law is continued in effect for that purpose.
- 15 (b) The changes in law made by this Act do not affect the
- 16 validity of a disciplinary action or other proceeding that was
- 17 initiated against a real estate inspector license holder before
- 18 September 1, 2021, and that is pending before a court or other
- 19 governmental entity on that date.
- 20 SECTION 16. This Act takes effect September 1, 2021.
