5	SECTION 1. Section 59.001, Property Code, is amended by
6	adding Subdivision (4-a) to read as follows:
7	(4-a) "Vehicle storage facility" has the meaning
8	assigned by Section 2303.002, Occupations Code.
9	SECTION 2. Section 59.043(a), Property Code, is amended to
10	read as follows:
11	(a) The lessor's notice to the tenant of the claim must
12	contain:
13	(1) an itemized account of the claim;

- (2) the name, address, and telephone number of the 14
- lessor or the lessor's agent; 15
- (3) a statement that the contents of the self-service 16
- 17 storage facility have been seized under the contractual landlord's

- 19 (4) a statement that if the tenant fails to satisfy the
- 20 claim on or before the 14th day after the date the notice is
- delivered, the property may be $\underline{\hspace{0.1cm}}$, as applicable: 21
- 22 (A) sold at public auction <u>under this subchapter;</u>

- 24 (B) towed to a vehicle storage facility and

- 1 disposed of by the vehicle storage facility under Subchapter D,
- 2 Chapter 2303, Occupations Code; and
- 3 (5) a statement underlined or printed in conspicuous
- 4 bold print requesting a tenant who is in military service to notify
- 5 the lessor of the status of the tenant's current military service

- 7 SECTION 3. Chapter 59, Property Code, is amended by adding
- 8 Subchapter D to read as follows:
- 9 SUBCHAPTER D. TOWING OF CERTAIN PROPERTY TO VEHICLE STORAGE
- 10 <u>FACILITY</u>
- Sec. 59.051. APPLICABILITY. This subchapter applies only
- 12 to property that is:
- 13 (1) a motor vehicle, trailer, or semitrailer for which
- 14 a title or registration is required under Chapter 501 or 502,
- 15 <u>Transportation Code;</u>
- 16 (2) a motorboat, vessel, or outboard motor for which a
- 17 certificate of title is required under Subchapter B, Chapter 31,
- 18 Parks and Wildlife Code; or
- 19 (3) a motor vehicle, trailer, semitrailer, motorboat,
- 20 vessel, or outboard motor registered or titled outside this state.
- 21 Sec. 59.052. TRANSFER OF CERTAIN PROPERTY TO VEHICLE
- 22 STORAGE FACILITY. Notwithstanding Subchapter C, a lessor who takes
- 23 possession of property to which this subchapter applies to enforce
- 24 a lien under this chapter may transfer possession of the property
- 25 and have the property towed to a vehicle storage facility for
- 26 disposition by the vehicle storage facility under Subchapter D,
- 27 Chapter 2303, Occupations Code, if:

- 1 (1) the transfer of possession and towing is
- 2 authorized under a written rental agreement between the lessor and
- 3 tenant;
- 4 (2) the lessor gives written notice of the lessor's
- 5 claim to the tenant as required under Section 59.042(a) in the

- 7 (3) the tenant fails to satisfy the claim on or before

- 11 (4) the vehicle storage facility agrees in writing to
- 12 accept possession of the property.
- Sec. 59.053. LIEN EXTINGUISHED. A lessor's lien on
- 14 property towed to a vehicle storage facility under Section 59.052
- 15 <u>is extinguished when the property is towed from the self-service</u>
- 16 storage facility.
- 17 Sec. 59.054. OTHER RIGHTS AND REMEDIES NOT AFFECTED.
- 18 Except as provided by Section 59.053, this subchapter does not
- 19 affect any right or remedy of the lessor at law or in equity.
- Sec. 59.055. LESSOR'S LIABILITY FOR PROPERTY. A lessor is
- 21 <u>not liable to a tenant for any damage to property that the lessor</u>
- 22 <u>has towed under Section 59.052 that occurs during the tow or after</u>
- 23 the property is towed from the self-service storage facility.
- SECTION 4. Chapter 2303, Occupations Code, is amended by
- 25 adding Subchapter E to read as follows:

- 1 SUBCHAPTER E. ACCEPTANCE AND DISPOSITION OF CERTAIN PROPERTY FROM
- 2 SELF-SERVICE STORAGE FACILITY
- 3 Sec. 2303.201. DEFINITIONS. In this subchapter, "lessor"
- 4 and "self-service storage facility" have the meanings assigned by
- 5 Section 59.001, Property Code.
- 6 Sec. 2303.202. APPLICABILITY. This subchapter applies only
- 7 to property described by Section 59.051, Property Code.
- 8 Sec. 2303.203. ACCEPTANCE OF PROPERTY. A vehicle storage
- 9 facility shall accept property from a lessor who has transferred
- 10 possession of the property from a self-service storage facility to
- 11 the vehicle storage facility under Section 59.052, Property Code.
- 12 Sec. 2303.204. DISPOSITION OF PROPERTY. A vehicle storage
- 13 facility that accepts property under Section 2303.203 may dispose
- 14 of the property in the manner provided by Subchapter D for a vehicle
- 15 received by a facility as described by Section 2303.151.
- SECTION 5. This Act takes effect September 1, 2021.
