## A BILL TO BE ENTITLED

AN ACT

- 2 relating to the imposition of tolls on Fairmont Parkway in Harris
- 3 County.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 228.011(a), Transportation Code, is
- 6 amended to read as follows:
- 7 (a) This section applies only to a county acting under
- 8 Chapter 284 for:
- 9 (1) the widening, expansion, reconstruction, and
- 10 continued operation of existing toll projects of the county; or
- 11 (2) the development, construction, and operation of
- 12 all or a portion of any of the following toll projects, a component
- 13 of that project, or the functional equivalent of that project:
- 14 (A) Beltway 8 Tollway East, between US 59 North
- 15 and US 90 East;
- 16 (B) Hardy Downtown Connector, consisting of the
- 17 proposed direct connection from the Hardy Toll Road southern
- 18 terminus at Loop 610 to downtown Houston;
- 19 (C) State Highway 288, between US 59 and Grand
- 20 Parkway South (State Highway 99);
- 21 (D) US 290 Toll Lanes, between IH 610 West and the
- 22 Grand Parkway Northwest (State Highway 99);
- (E) [Fairmont Parkway East, between Beltway 8
- 24 East and Grand Parkway East (State Highway 99);

- 1 [(F)] South Post Oak Road Extension, between IH
- 2 610 South and near the intersection of Beltway 8 and Hillcroft in
- 3 the vicinity of the Fort Bend Parkway Tollway;
- 4 (F) [<del>(C)</del>] Westpark Toll Road Phase II, between
- 5 Grand Parkway (State Highway 99) and FM 1463;
- 6 (G) [(H)] Fort Bend Parkway, between State
- 7 Highway 6 and the Brazos River; and
- 8 (H) [<del>(I)</del>] Montgomery County Parkway, between
- 9 State Highway 242 and the Grand Parkway (State Highway 99), and if
- 10 the Grand Parkway project has not begun construction, a nontolled
- 11 extension of the Montgomery County Parkway to allow a connection to
- 12 Interstate Highway 45.
- SECTION 2. Subchapter B, Chapter 372, Transportation Code,
- 14 is amended by adding Section 372.059 to read as follows:
- Sec. 372.059. FAIRMONT PARKWAY. A toll project entity may
- 16 not impose a toll on any portion of Fairmont Parkway in Harris
- 17 County.
- SECTION 3. This Act takes effect September 1, 2021.
