A BILL TO BE ENTITLED

AN ACT

- 2 relating to matters regarding educators, including the composition
- 3 of the State Board for Educator Certification, the board's
- 4 disciplinary proceedings, and a public school teacher's
- 5 notification of resignation from employment.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 21.033, Education Code, is amended by
- 8 adding Subsection (a-1) to read as follows:
- 9 (a-1) At least two of the members appointed under Subsection
- 10 (a)(1), (2), or (3) must be from a school district with fewer than
- 11 999 students in membership for purposes of average daily
- 12 <u>attendance.</u>

- SECTION 2. Subchapter B, Chapter 21, Education Code, is
- 14 amended by adding Sections 21.065, 21.066, and 21.067 to read as
- 15 follows:
- Sec. 21.065. FINDINGS OF FACT. In adopting findings of fact
- 17 in a disciplinary proceeding initiated under this chapter to
- 18 suspend or revoke a certificate or permit, the board must include in
- 19 the findings any available information regarding the respondent's
- 20 response to the allegations on which the proceeding is based.
- Sec. 21.066. ALTERNATIVES TO SUSPENSION. Before suspending
- 22 a certificate or permit issued under this subchapter, including for
- 23 <u>a reason related to contract abandonment, the board must consider</u>
- 24 requiring additional continuing education or training as an

- 1 <u>alternative to suspension.</u>
- 2 Sec. 21.067. NOTICE TO TEACHER REGARDING SUSPENSION OR
- 3 REVOCATION OF CERTIFICATE OR PERMIT. (a) In this section,
- 4 "teacher" means a superintendent, principal, supervisor, classroom
- 5 teacher, school counselor, or other full-time professional
- 6 employee who is required to hold a certificate issued under this
- 7 <u>subchapter.</u>
- 8 (b) On the suspension or revocation of a teacher's
- 9 certificate or permit issued under this subchapter, the board shall
- 10 promptly notify the teacher of the suspension or revocation by
- 11 certified mail and, if available, e-mail. The notice must include
- 12 the basis for the suspension or revocation.
- SECTION 3. Section 21.105, Education Code, is amended by
- 14 amending Subsections (a) and (c) and adding Subsection (d) to read
- 15 as follows:
- 16 (a) A teacher employed under a probationary contract for the
- 17 following school year may relinquish the position and leave the
- 18 employment of the district at the end of a school year without
- 19 penalty by filing with the board of trustees or its designee a
- 20 written resignation not later than the 30th [45th] day before the
- 21 first day of instruction of the following school year. A written
- 22 resignation mailed by prepaid certified or registered mail to the
- 23 president of the board of trustees or the board's designee at the
- 24 post office address of the district is considered filed at the time
- 25 of mailing.
- 26 (c) Subject to Subsection (d), on [On] written complaint by
- 27 the employing district, the State Board for Educator Certification

- 1 may impose sanctions against a teacher employed under a
- 2 probationary contract who:
- 3 (1) resigns;
- 4 (2) fails without good cause to comply with Subsection
- 5 (a) or (b); and
- 6 (3) fails to perform the contract.
- 7 (d) If a teacher fails to timely file a written resignation
- 8 <u>as required by Subsection (a), the State Board for Educator</u>
- 9 Certification may not revoke the teacher's certificate under
- 10 Subsection (c) if the teacher:
- 11 (1) has no disciplinary history with the board; and
- 12 (2) demonstrates that the notice of resignation given
- 13 was reasonable under the circumstances.
- 14 SECTION 4. Section 21.160, Education Code, is amended by
- 15 amending Subsections (a) and (c) and adding Subsection (d) to read
- 16 as follows:
- 17 (a) A teacher employed under a continuing contract may
- 18 relinquish the position and leave the employment of the district at
- 19 the end of a school year without penalty by filing with the board of
- 20 trustees or its designee a written resignation not later than the
- $21 \quad \underline{30th} \quad [45th]$ day before the first day of instruction of the following
- 22 school year. A written resignation mailed by prepaid certified or
- 23 registered mail to the president of the board of trustees or the
- 24 board's designee at the post office address of the district is
- 25 considered filed at time of mailing.
- 26 (c) Subject to Subsection (d), on [On] written complaint by
- 27 the employing district, the State Board for Educator Certification

- 1 may impose sanctions against a teacher who is employed under a
- 2 continuing contract that obligates the district to employ the
- 3 person for the following school year and who:
- 4 (1) resigns;
- 5 (2) fails without good cause to comply with Subsection
- 6 (a) or (b); and
- 7 (3) fails to perform the contract.
- 8 <u>(d) If a teacher fails to timely file a written resignation</u>
- 9 as required by Subsection (a), the State Board for Educator
- 10 Certification may not revoke the teacher's certificate under
- 11 Subsection (c) if the teacher:
- 12 (1) has no disciplinary history with the board; and
- 13 (2) demonstrates that the notice of resignation given
- 14 was reasonable under the circumstances.
- SECTION 5. Section 21.210, Education Code, is amended by
- 16 amending Subsections (a) and (c) and adding Subsection (d) to read
- 17 as follows:
- 18 (a) A teacher employed under a term contract with a school
- 19 district may relinquish the teaching position and leave the
- 20 employment of the district at the end of a school year without
- 21 penalty by filing a written resignation with the board of trustees
- 22 or the board's designee not later than the 30th [45th] day before
- 23 the first day of instruction of the following school year. A written
- 24 resignation mailed by prepaid certified or registered mail to the
- 25 president of the board of trustees or the board's designee at the
- 26 post office address of the district is considered filed at the time
- 27 of mailing.

- 1 (c) <u>Subject to Subsection (d), on [On]</u> written complaint by 2 the employing district, the State Board for Educator Certification 3 may impose sanctions against a teacher who is employed under a term 4 contract that obligates the district to employ the person for the
- 6 (1) resigns;

following school year and who:

- 7 (2) fails without good cause to comply with Subsection
- 8 (a) or (b); and

- 9 (3) fails to perform the contract.
- 10 <u>(d) If a teacher fails to timely file a written resignation</u>
- 11 as required by Subsection (a), the State Board for Educator
- 12 Certification may not revoke the teacher's certificate under
- 13 <u>Subsection (c) if the teacher:</u>
- 14 (1) has no disciplinary history with the board; and
- 15 (2) demonstrates that the notice of resignation given
- 16 was reasonable under the circumstances.
- SECTION 6. Section 21.033(a-1), Education Code, as added by
- 18 this Act, requiring that at least two members of the State Board for
- 19 Educator Certification appointed under Subsection (a)(1), (2), or
- 20 (3) of that section be from a school district with fewer than 999
- 21 students in membership for purposes of average daily attendance,
- 22 does not affect the entitlement of members described by those
- 23 subdivisions serving on the board immediately before the effective
- 24 date of this Act to continue to carry out the members' duties for
- 25 the remainder of the members' terms. The governor shall appoint
- 26 members who meet the requirements under Section 21.033(a-1),
- 27 Education Code, as added by this Act, if necessary, on the first two

- 1 vacancies that occur after the effective date of this Act of a board
- 2 position held by a member under Subsection (a)(1), (2), or (3) of
- 3 that section.
- 4 SECTION 7. Sections 21.065, 21.066, 21.105(d), 21.160(d),
- 5 and 21.210(d), Education Code, as added by this Act, apply only to a
- 6 disciplinary proceeding initiated by the State Board for Educator
- 7 Certification on or after the effective date of this Act. A
- 8 disciplinary proceeding commenced before the effective date of this
- 9 Act is governed by the law in effect immediately before that date,
- 10 and the former law is continued in effect for that purpose.
- 11 SECTION 8. Section 21.067, Education Code, as added by this
- 12 Act, applies only to a suspension or revocation of a teacher's
- 13 certificate or permit by the State Board for Educator Certification
- 14 occurring on or after the effective date of this Act.
- 15 SECTION 9. Sections 21.105(a), 21.160(a), and 21.210(a),
- 16 Education Code, as amended by this Act, apply beginning with the
- 17 written resignation required to be filed by a teacher who intends to
- 18 leave employment with a school district at the end of the 2021-2022
- 19 school year.
- 20 SECTION 10. This Act takes effect September 1, 2021.
