4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle A, Title 5, Government Code, is amended
6	by adding Chapter 561 to read as follows:
7	CHAPTER 561. COMPTROLLER'S PUBLIC INFORMATION INTERNET WEBSITE
8	Sec. 561.001. DEFINITIONS. In this chapter:
9	(1) "Governmental entity" means:
10	(A) a state agency in the executive, legislative,
11	or judicial branch of state government, including an institution of
12	higher education as defined by Section 61.003, Education Code; or
13	(B) a political subdivision of this state.
14	(2) "Public information" means a public or legal
15	notice that a governmental entity is required to publish under a
16	statute or rule of this state and any other information a
17	governmental entity submits for publication on the public
18	information Internet website.
19	(3) "Public information Internet website" means the
20	official state Internet website developed and maintained by the
21	comptroller under this chapter.
22	Sec. 561.002. PUBLIC INFORMATION INTERNET WEBSITE. (a)
23	The comptroller shall develop and maintain an Internet website of
24	public information, including archived public information.

1	(b) The public information Internet website must be
2	designed to:
3	(1) allow a governmental entity to easily post public
4	information on the Internet website or the comptroller to post
5	public information on receipt of the information from the entity;
6	(2) allow the public to search and sort the public
7	information on the Internet website by:
8	(A) a specific municipality or county;
9	(B) a governmental entity name;
10	(C) the type of governmental entity;
11	(D) the submission date of the public
12	<pre>information;</pre>
13	(E) the event or deadline date stated in the
14	<pre>public information; and</pre>
15	(F) any additional criteria approved by the
16	<pre>comptroller;</pre>
17	(3) allow the public to search and view archived
18	public information posted on the Internet website;
19	(4) allow a person to subscribe to e-mail notices of
20	public information associated with a specific governmental entity;
21	(5) be easily accessible by the public 24 hours a day,
22	seven days a week, through the Texas.gov Internet website that
23	includes a direct link to the public information Internet website;
24	(6) have a unique and easy to remember Internet
25	website address; and
26	(7) have adequate systems for information security and
27	backup and a contingency plan to address power outages, systematic

- 2 (c) The comptroller shall develop a process for a
- 3 governmental entity to access the public information Internet
- 4 website to post public information or modify information previously
- 5 posted by the entity or to submit the information or modified
- 6 information to the comptroller for posting on the Internet website.
- 7 (d) In developing the public information Internet website,
- 8 the comptroller shall coordinate with the Office of Court
- 9 Administration of the Texas Judicial System regarding the Internet
- 10 website maintained by the office as required by Section 72.034, as
- 11 added by Chapter 606 (S.B. 891), Acts of the 86th Legislature,
- 12 Regular Session, 2019, to eliminate unnecessary duplication and
- 13 ensure each Internet website at a minimum includes a link to the
- 14 <u>other Internet website.</u>
- 15 Sec. 561.003. SUBMISSION OF PUBLIC INFORMATION; EXCEPTION.
- 16 (a) Subject to Subsection (b), each governmental entity:
- 17 (1) shall submit for inclusion on the public
- 18 information Internet website any public or legal notice a statute
- 19 or rule of this state requires the entity to publish in a newspaper;
- 20 and
- 21 (2) may submit any other public information the entity
- 22 <u>elects to submit.</u>
- 23 (b) A governmental entity is not required to submit for
- 24 inclusion on the public information Internet website any public or
- 25 legal notice that another statute or rule of this state requires the
- 26 entity to publish on the Internet website maintained by the Office
- 27 of Court Administration of the Texas Judicial System as required by

- 3 Sec. 561.004. EFFECT OF PUBLICATION ON PUBLIC INFORMATION
- 4 INTERNET WEBSITE. (a) Notwithstanding any other law other than
- 5 Subsection (b), a governmental entity's submission of public
- 6 information to the public information Internet website satisfies a
- 7 requirement imposed by another statute or rule of this state to
- 8 publish notice in a newspaper.
- 9 (b) A governmental entity's submission of public
- 10 information to the public information Internet website does not
- 11 satisfy a requirement imposed by another statute or rule of this
- 12 state to publish notice on the Internet website maintained by the
- 13 Office of Court Administration of the Texas Judicial System under
- 14 <u>Section 72.034</u>, as added by Chapter 606 (S.B. 891), Acts of the 86th
- 15 <u>Legislature, Regular Session, 2019.</u>
- 16 <u>(c) A governmental entity at the entity's discretion may</u>
- 17 publish notice of public information in any other format authorized
- 18 by a statute or rule of this state in addition to submitting the
- 19 public information for publication on the public information
- 20 Internet website.
- 21 Sec. 561.005. IMMUNITY FROM LIABILITY OR PENALTY. A
- 22 governmental entity that in good faith attempts to submit public
- 23 information to the public information Internet website is not
- 24 subject to liability or other penalty for failing to post the public
- 25 <u>information to the public information Internet website or to</u>
- 26 deliver an e-mail notice of the posted public information.
- 27 SECTION 2. As soon as practicable after the effective date

- 1 of this Act, but not later than September 1, 2022:
- 2 (1) the comptroller of public accounts shall develop
- 3 the public information Internet website required by Chapter 561,
- 4 Government Code, as added by this Act; and
- 5 (2) each governmental entity in this state shall begin
- 6 submitting public information to the public information Internet
- 7 website in the format and manner required by the comptroller and
- 8 Chapter 561, Government Code, as added by this Act.
- 9 SECTION 3. This Act takes effect September 1, 2021.
