A BILL TO BE ENTITLED

AN ACT

2 relating to the operation and administration of the State Office of 3 Administrative Hearings, including procedures during a declared 4 disaster and the use of videoconferencing technology to conduct 5 administrative hearings.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 SECTION 1. Section 12.032, Agriculture Code, is amended to 8 read as follows:

Sec. 12.032. HEARINGS CONDUCTED BY [COOPERATION WITH] STATE 9 OFFICE OF ADMINISTRATIVE HEARINGS. (a) [The commissioner and the 10 chief administrative law judge of the State Office 11 -of 12 Administrative Hearings by rule shall adopt a memorandum of understanding under which the State Office of Administrative 13 Hearings conducts hearings for the department under this code. The 14 memorandum of understanding shall require the chief administrative 15 16 law judge, the department, and the commissioner to cooperate in 17 connection with the hearings under this code and may authorize the State Office of Administrative Hearings to perform any 18 administrative act, including giving of notice, that is required to 19 be performed by the department or the commissioner under this code. 20 21 The memorandum of understanding shall also require that hearings under this section be held at a location agreed upon by the State 22 23 Office of Administrative Hearings and the department.

24 [(b)] For a hearing conducted by the State Office of

1 Administrative Hearings under this code, the department and the 2 commissioner retain the authority to decide whether the 3 administrative law judge conducting the hearing for the State 4 Office of Administrative Hearings shall:

5 (1) enter the final decision in the case after 6 completion of the hearing; or

7 (2) propose a decision to the department or the8 commissioner for final consideration.

9 (b) [(c)] Any provision of this code that provides that the 10 department or the commissioner take an action at a hearing means:

(1) that the department or the commissioner shall take the action after the receipt of a proposal for decision from the State Office of Administrative Hearings regarding the hearing conducted by that office; or

15 (2) if so directed by the department or the 16 commissioner, the State Office of Administrative Hearings shall 17 enter the final decision in the case after completion of the 18 hearing.

19 (c) [(d)] The department shall prescribe rules of procedure 20 for any cases not heard by the State Office of Administrative 21 Hearings.

[(e) The department by interagency contract shall reimburse the State Office of Administrative Hearings for the costs incurred in conducting administrative hearings for the department. The department may pay an hourly fee for the costs of conducting these hearings or a fixed annual fee negotiated biennially by the department and the State Office of Administrative Hearings to

Subchapter F, Chapter 411, Government Code, is amended by adding Section 411.1411 to read as follows: 6 Sec. 411.1411. ACCESS TO CRIMINAL HISTORY RECORD 7 8 INFORMATION: STATE OFFICE OF ADMINISTRATIVE HEARINGS. (a) In this section, "office" means the State Office of Administrative 9 10 Hearings. (b) The office is entitled to obtain from the department 11 12 criminal history record information maintained by the department or another criminal justice agency that relates to a person who is: 13 (1) an employee of, or an applicant for employment 14 15 with, the office; 16 (2) a consultant, contract employee, volunteer, or 17 intern of the office, or an applicant to serve in one of those 18 capacities; or 19 (3) a current or proposed contractor or subcontractor of the office. 20 21 (c) Criminal history record information obtained by the office under Subsection (b) may not be released or disclosed to any 22 person except by court order or with the consent of the person who 23 24 is the subject of the criminal history record information. (d) The office shall promptly destroy criminal history 25 26 record information obtained under Subsection (b) after a final determination is made in the matter for which the information is 27

2	SECTION 3. Subchapter C, Chapter 2003, Government Code, is
3	amended by adding Section 2003.0401 to read as follows:
4	Sec. 2003.0401. DEPUTY CHIEF ADMINISTRATIVE LAW JUDGE. (a)
5	The chief administrative law judge shall appoint a deputy chief
6	administrative law judge. To be eligible for appointment as a
7	deputy chief administrative law judge, an individual must:
8	(1) be licensed to practice law in this state; and
9	(2) meet other requirements prescribed by the chief
10	administrative law judge.
11	(b) The deputy chief administrative law judge shall:
12	(1) perform the duties the chief administrative law
13	judge is required by law to perform when the chief administrative
14	law judge is absent or unable to act;
15	(2) supervise administrative law judges employed by
16	the office, including individuals appointed as senior or master
17	administrative law judges under Section 2003.0411; and
18	(3) perform other duties assigned by the chief
19	administrative law judge.
20	(c) The deputy chief administrative law judge serves at the
21	pleasure of the chief administrative law judge.
22	SECTION 4. Section 2003.041(c), Government Code, is amended
23	to read as follows:
24	(c) An administrative law judge employed by the office is
25	not responsible to or subject to the supervision, direction, or
26	indirect influence of any person other than the chief
27	administrative law judge or <u>a deputy chief administrative law</u>

judge, or [a] senior or master administrative law judge, designated by the chief administrative law judge. In particular, an administrative law judge employed by the office is not responsible to or subject to the supervision, direction, or indirect influence of an officer, employee, or agent of another state agency who performs investigative, prosecutorial, or advisory functions for the other agency.

8 SECTION 5. Section 2003.0411(a), Government Code, is 9 amended to read as follows:

10 (a) The chief administrative law judge may appoint senior or 11 master administrative law judges to perform duties assigned by the 12 chief administrative law judge <u>or the deputy chief administrative</u> 13 law judge.

SECTION 6. Section 2003.045, Government Code, is amended to read as follows:

Sec. 2003.045. OVERSIGHT OF ADMINISTRATIVE LAW JUDGES. The chief administrative law judge <u>or deputy chief administrative law</u> <u>judge</u> may designate senior or master administrative law judges to oversee the training, evaluation, discipline, and promotion of administrative law judges employed by the office.

21 SECTION 7. Subchapter C, Chapter 2003, Government Code, is 22 amended by adding Section 2003.0501 to read as follows:

23 <u>Sec. 2003.0501. MODIFICATION OR SUSPENSION OF CERTAIN</u> 24 <u>PROVISIONS RELATING TO ADMINISTRATIVE PROCEEDINGS AFFECTED BY</u> 25 <u>DISASTER. (a) In this section, "disaster" has the meaning assigned</u> 26 <u>by Section 418.004.</u>

27 (b) Notwithstanding any other law, the chief administrative

No. 2580 1 law judge may modify or suspend a procedure governing the conduct of 2 an administrative hearing or alternative dispute resolution 3 procedure authorized by this chapter that is affected by a disaster during the period for which a disaster declaration issued by the 4 5 governor is in effect. (c) An order of the chief administrative law judge issued 6 7 under this section may not extend for more than 30 days from the date on which the order was signed unless renewed by the chief 8 administrative law judge. 9 10 (d) If a disaster prevents the chief administrative law judge from acting under this section, the deputy 11 chief 12 administrative law judge may act on behalf of the chief 13 administrative law judge. 14 (e) To the extent practicable, an order issued under this section shall conform to the requirements prescribed by law for an 15 order issued by the supreme court of this state under Section 16 22.0035. 17 SECTION 8. Subchapter C, Chapter 2003, Government Code, is 18 19 amended by adding Sections 2003.0551 and 2003.0552 to read as 20 follows: 21 Sec. 2003.0551. USE OF VIDEOCONFERENCING TECHNOLOGY FOR 22 ADMINISTRATIVE PROCEEDINGS. (a) In this section, "videoconferencing technology" has the meaning assigned by Section 23 24 402.0213. 25 (b) Notwithstanding any other law, the chief administrative 26 law judge, deputy chief administrative law judge, or an 27 administrative law judge assigned to preside over a contested case

H.B. No. 2580 1 or alternative dispute resolution proceeding may order the use of 2 videoconferencing technology to conduct a proceeding the office is authorized to conduct. The presiding judge and the parties and 3 their attorneys may participate in the proceeding from any location 4 5 when using videoconferencing technology. 6 (c) The office may assist a party in attending a proceeding 7 conducted by videoconferencing technology by making the technology available for the party's use at the permanent location of the 8 office nearest to the party if: 9 10 (1) the party: 11 (A) is not represented by counsel; or 12 (B) is unable to participate in the proceeding due to insufficient access to videoconferencing technology; and 13 14 (2) making the technology available does not pose a 15 credible risk to the health or safety of employees or other persons physically present at the office. 16 17 Sec. 2003.0552. USE OF ELECTRONIC FILING TECHNOLOGY FOR SERVICE OF ADMINISTRATIVE DECISIONS AND ORDERS. Notwithstanding 18 19 any other law, the office may deliver a decision or order issued by the office using: 20 21 (1) an electronic filing system, as defined by Section 72.031, that is approved by the Office of Court Administration of 22 23 the Texas Judicial System; or 24 (2) a method of electronic delivery other than the system described by Subdivision (1), including by e-mail sent to 25 26 the current e-mail address of the party's attorney of record or, if the party is not represented by counsel, to the party's current 27

1 <u>e-mail address.</u>

2 SECTION 9. Section 402.073, Labor Code, is amended to read 3 as follows:

Sec. 402.073. HEARINGS CONDUCTED BY [COOPERATION WITH] 4 5 STATE OFFICE OF ADMINISTRATIVE HEARINGS. (a) [The commissioner and the chief administrative law judge of the State Office of 6 Administrative Hearings shall adopt a memorandum of understanding 7 8 governing administrative procedure law hearings under this subtitle conducted by the State Office of Administrative Hearings 9 10 in the manner provided for a contested case hearing under Chapter 2001, Government Code. The memorandum of understanding must 11 12 address the payment of costs by parties to a medical fee dispute under Section 413.0312. 13

In a case in which a hearing is conducted by the State Office of Administrative Hearings under Section 413.031 or 413.055, the administrative law judge who conducts the hearing for the State Office of Administrative Hearings shall enter the final decision in the case after completion of the hearing.

19 (b) [(c)] In a case in which a hearing is conducted in 20 conjunction with Section [402.072,] 407.046, 408.023, 415.0215, or 21 415.034, and in other cases under this subtitle that are not subject 22 to Subsection (a) [(b)], the administrative law judge who conducts 23 the hearing for the State Office of Administrative Hearings shall 24 propose a decision to the commissioner for final consideration and 25 decision by the commissioner.

26 (c) [(d)] The notice of the commissioner's order must
 27 include a statement of the right of the person to judicial review of

1 the order.

2 (d) [(e)] In issuing an order under this section, the 3 commissioner shall comply with the requirements applicable to a 4 state agency under Section 2001.058, Government Code.

5 SECTION 10. Section 524.034, Transportation Code, is 6 amended to read as follows:

Sec. 524.034. HEARING LOCATION. A hearing under this8 subchapter shall be held:

9 (1) at a location designated by the State Office of 10 Administrative Hearings:

(A) in the county of arrest if the arrest
occurred in a county with a population of 300,000 or more; or

(B) in the county in which the person is alleged to have committed the offense for which the person was arrested or not more than 75 miles from the county seat of the county in which the person was arrested; or

17 (2) <u>if the administrative law judge presiding over the</u> 18 <u>hearing issues an order under Section 2003.0551, Government Code</u> 19 [with the consent of the person and the department], by telephone <u>or</u> 20 <u>video</u> conference call.

21 SECTION 11. Section 724.041(e), Transportation Code, is 22 amended to read as follows:

(e) A hearing shall be held:

23

24 (1) at a location designated by the State Office of25 Administrative Hearings:

26 (A) in the county of arrest if the county has a27 population of 300,000 or more; or

1 (B) in the county in which the person was alleged to have committed the offense for which the person was arrested or 2 not more than 75 miles from the county seat of the county of arrest 3 if the population of the county of arrest is less than 300,000; or 4 5 (2) if the administrative law judge presiding over the 6 hearing issues an order under Section 2003.0551, Government Code [with the consent of the person requesting the hearing and the 7 8 department], by telephone or video conference call. 9 SECTION 12. The following provisions are repealed: (1)Sections 2003.021(c) and (d), 2003.024(a-2), 10 2003.050(c), and 2003.108, Government Code; and 11 (2) Section 40.004, Insurance Code. 12 SECTION 13. This Act takes effect immediately if 13 it receives a vote of two-thirds of all the members elected to each 14 15 house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate 16

effect, this Act takes effect September 1, 2021.
