- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 2269.056(b), Government Code, is amended
- 6 to read as follows:
- 7 (b) The governmental entity shall base its selection among
- 8 offerors on applicable criteria listed for the particular method
- 9 used. The governmental entity shall publish in the request for
- 10 proposals or qualifications:
- 11 (1) the criteria that will be used to evaluate the
- 12 offerors;
- 13 (2) the applicable weighted value for each criterion;
- 14 and
- 15 (3) [for state agencies,] a detailed methodology for
- 16 scoring each criterion.
- 17 SECTION 2. Subchapter B, Chapter 2269, Government Code, is
- 18 amended by adding Section 2269.060 to read as follows:
- 19 Sec. 2269.060. DOCUMENTS RELATED TO EVALUATION AND RANKING.
- 20 (a) An offeror who submits a bid, proposal, or response to a
- 21 request for qualifications for a construction contract under this
- 22 chapter may, after the contract is awarded, make a request in
- 23 writing to the governmental entity to provide documents related to
- 24 the evaluation of the offeror's submission.

- 1 (b) Not later than the 30th day after the date a request is
- 2 made under Subsection (a), the governmental entity shall deliver to
- 3 the offeror the documents relating to the evaluation of the
- 4 submission including, if applicable, its ranking of the submission.
- 5 SECTION 3. Section 2269.153, Government Code, is amended to
- 6 read as follows:
- 7 Sec. 2269.153. PREPARATION OF REQUEST. (a) In this
- 8 <u>section</u>, "civil works project" has the meaning assigned by Section
- 9 2269.351.
- 10 <u>(b)</u> The governmental entity shall prepare a request for
- 11 competitive sealed proposals that includes construction documents,
- 12 selection criteria and the weighted value for each criterion,
- 13 estimated budget, project scope, estimated project completion
- 14 date, and other information that a contractor may require to
- 15 respond to the request.
- (c) Except as provided by Subsection (d), for civil works
- 17 projects, the weighted value assigned to price must be at least 50
- 18 percent of the total weighted value of all selection criteria.
- 19 (d) If the governing body of a governmental entity
- 20 determines that assigning a lower weighted value to price is in the
- 21 public interest, the governmental entity may assign to price a
- 22 weighted value of not less than 40 percent of the total weighted
- 23 <u>value of all selection criteria.</u>
- SECTION 4. Section 2269.155, Government Code, is amended by
- 25 adding Subsection (d) to read as follows:

- 1 evaluations, including any scores, public and provide them to all
- 2 offerors.
- 3 SECTION 5. Section 2269.452(a), Government Code, is amended
- 4 to read as follows:
- 5 (a) This chapter may be enforced through an action for
- 6 declaratory or injunctive relief filed not later than the <u>15th</u>
- 7 <u>calendar</u> [10th] day after the date on which the contract is awarded.
- 8 SECTION 6. The change in law made by this Act applies only
- 9 to a contract for which a governmental entity first advertises or
- 10 otherwise solicits bids, proposals, offers, or qualifications or
- 11 makes a similar solicitation on or after the effective date of this
- 12 Act. A contract for which a governmental entity first advertises or
- 13 otherwise solicits bids, proposals, offers, or qualifications or
- 14 makes a similar solicitation before the effective date of this Act
- 15 is governed by the law in effect on the date the advertisement or
- 16 solicitation is made, and that law is continued in effect for that
- 17 purpose.
- SECTION 7. This Act takes effect September 1, 2021.
