14	229.001, Local Government Code.
15	(2) "Firearm" has the meaning assigned by Section

17	(3) "Firearm accessory" means an item that is used in
18	conjunction with or mounted on a firearm but is not essential to the
19	basic function of the firearm. The term includes a detachable
20	firearm magazine.
21	(4) "State funds" means money appropriated by the
22	legislature or money under the control or direction of a state
23	agency.
24	(b) Notwithstanding any other law, an agency of this state,

1	a political subdivision of this state, or a law enforcement officer
2	or other person employed by an agency of this state or a political
3	subdivision of this state may not contract with or in any other
4	manner provide assistance to a federal agency or official with
5	respect to the enforcement of a federal statute, order, rule, or
6	regulation that:
7	(1) imposes a prohibition, restriction, or other
8	regulation that does not exist under the laws of this state; and
9	(2) relates to:
10	(A) a registry requirement for a firearm, a
11	firearm accessory, or ammunition;
12	(B) a requirement that an owner of a firearm, a

14	of owning, possessing, or carrying the firearm, firearm accessory,

23	(E) a program that requires an owner of a
24	firearm, a firearm accessory, or ammunition to sell the firearm,
25	firearm accessory, or ammunition.
26	(c) Subsection (b) does not apply to a contract or agreement
27	to provide assistance in the enforcement of a federal statute,

1 order, rule, or regulation in effect on January 19, 2021. 2 (d) A political subdivision of this state may not receive state funds if the political subdivision enters into a contract or 3 adopts a rule, order, ordinance, or policy under which the 4 5 political subdivision requires or assists with the enforcement of any federal statute, order, rule, or regulation described by 6 7 Subsection (b) or, by consistent actions, requires or assists with 8 the enforcement of any federal statute, order, rule, or regulation described by Subsection (b). State funds for the political 9 subdivision shall be denied for the fiscal year following the year 10 in which a final judicial determination in an action brought under 11 12 this section is made that the political subdivision has required or assisted with the enforcement of any federal statute, order, rule, 13 14 or regulation described by Subsection (b). 15 (e) Any individual residing in the jurisdiction of a political subdivision of this state may file a complaint with the 16 17 attorney general if the individual offers evidence to support an allegation that the political subdivision has entered into a 18 19 contract or adopted a rule, order, ordinance, or policy under which the political subdivision requires or assists with the enforcement 20 of any federal statute, order, rule, or regulation described by 21 Subsection (b) or evidence to support an allegation that the 22 political subdivision, by consistent actions, requires or assists 23 24 with the enforcement of any federal statute, order, rule, or regulation described by Subsection (b). The individual must 25 26 include with the complaint the evidence the individual has that 27 supports the complaint.

1 (f) If the attorney general determines that a complaint filed under Subsection (e) against a political subdivision of this 2 3 state is valid, the attorney general may file a petition for a writ of mandamus or apply for other appropriate equitable relief in a 4 5 district court in Travis County or in a county in which the principal office of the political subdivision is located to compel 6 7 the political subdivision to comply with Subsection (b). The attorney general may recover reasonable expenses incurred in 8 obtaining relief under this subsection, including court costs, 9 10 reasonable attorney's fees, investigative costs, witness fees, and deposition costs. 11 12 (g) An appeal of a suit brought under Subsection (f) is governed by the procedures for accelerated appeals in civil cases 13 under the Texas Rules of Appellate Procedure. 17 (h) The attorney general shall defend any agency of this 18 state in a suit brought against the agency by the federal government 19 for an action or omission consistent with the requirements of this 20 section.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2021.
