- (c) Notwithstanding the time requirements of Subsection $\frac{(a)(11)}{(a)(12)}$, a person who is the foster parent of a child may file a suit to adopt a child for whom the person is providing foster care at any time after the person has been approved to adopt the child. The standing to file suit under this subsection applies only to the adoption of a child who is eligible to be adopted.
- 20 (d) A person described by Subsection (a)(14) [(a)(15)] has 21 standing to file an original suit only if:
- 22 (1) the person is filing an original suit jointly with 23 the other intended parent under the gestational agreement; or

- SECTION 2. Sections 102.0035(a) and (e), Family Code, are amended to read as follows:

- 1 (a) A pregnant woman or a parent of a child may execute a

- of a former parent whose parent-child relationship with the child 1 has been terminated by court order [an adult sibling of the child, a 2 grandparent of the child, an aunt who is a sister of a parent of the 3 child, or an uncle who is a brother of a parent of the child] if the 4 relative [adult sibling, grandparent, aunt, or uncle] files an 5 original suit or a suit for modification requesting managing 6 conservatorship of the child not later than the 90th day after the 7 date the parent-child relationship between the child and the parent is terminated in a suit filed by the Department of Family and 9 10 Protective Services requesting the termination of the parent-child relationship. 11
- SECTION 7. The changes in law made by this Act apply only to a suit affecting the parent-child relationship filed on or after the effective date of this Act. A suit affecting the parent-child relationship filed before that date is governed by the law in effect on the date the suit was filed, and that law is continued in effect for that purpose.
- 18 SECTION 8. This Act takes effect September 1, 2021.
