- 2 relating to establishing an advisory board to study surface water
- 3 and groundwater interaction.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. DEFINITIONS. In this Act:
- 6 (1) "Advisory board" means the Surface Water and
- 7 Groundwater Interaction Advisory Board.
- 8 (2) "Development board" means the Texas Water
- 9 Development Board.
- 10 SECTION 2. SURFACE WATER AND GROUNDWATER INTERACTION
- 11 ADVISORY BOARD ESTABLISHED. (a) The Surface Water and Groundwater
- 12 Interaction Advisory Board is established and consists of nine
- 13 persons as follows:
- 14 (1) the executive administrator of the development
- 15 board;
- 16 (2) one person to represent the interests of the Texas
- 17 Commission on Environmental Quality, recommended by the Texas
- 18 Commission on Environmental Quality and appointed jointly by the
- 19 chairs of the house natural resources committee and the senate
- 20 water and rural affairs committee;
- 21 (3) one person to represent the interests of river
- 22 authorities, recommended by the Texas Commission on Environmental
- 23 Quality and appointed jointly by the chairs of the house natural
- 24 resources committee and the senate water and rural affairs

- 1 committee;
- 2 (4) one person to represent the interests of
- 3 groundwater conservation districts, recommended by the Texas
- 4 Commission on Environmental Quality and appointed jointly by the
- 5 chairs of the house natural resources committee and the senate
- 6 water and rural affairs committee;
- 7 (5) two persons with academic or specialist knowledge
- 8 in the area of surface water and groundwater interaction, with one
- 9 appointed by the chair of the house natural resources committee and
- 10 another appointed by the chair of the senate water and rural affairs
- 11 committee;
- 12 (6) the chair of the house natural resources
- 13 committee;
- 14 (7) the chair of the senate water and rural affairs
- 15 committee; and
- 16 (8) one person from the office of the governor,
- 17 appointed by the governor.
- 18 (b) The executive administrator of the development board
- 19 serves as the chair of the advisory board.
- 20 SECTION 3. SURFACE WATER AND GROUNDWATER INTERACTION STUDY.
- 21 (a) The advisory board shall study:
- (1) the extent to which surface water and groundwater
- 23 interact in this state;
- 24 (2) challenges arising in this state from the
- 25 interaction of surface water and groundwater; and
- 26 (3) approaches to mitigating challenges arising in
- 27 this state from the interaction of surface water and groundwater.

- 1 (b) In conducting the study under this section, the advisory
- 2 board shall consult with:
- 3 (1) the Texas Commission on Environmental Quality;
- 4 (2) groundwater conservation districts; and
- 5 (3) river authorities.
- 6 SECTION 4. STUDY REPORT; EXPIRATION OF ACT. (a) The
- 7 advisory board shall deliver to the governor, the lieutenant
- 8 governor, the speaker of the house of representatives, and each
- 9 member of the legislature a report on the determinations of the
- 10 advisory board based on the study conducted under Section 3 of this
- 11 Act not later than December 1, 2022. The advisory board shall
- 12 deliver to the governor, the lieutenant governor, the speaker of
- 13 the house of representatives, or a member of the legislature
- 14 related information on request.
- 15 (b) The advisory board is abolished and this Act expires
- 16 January 1, 2023.
- 17 SECTION 5. EFFECTIVE DATE. This Act takes effect
- 18 immediately if it receives a vote of two-thirds of all the members
- 19 elected to each house, as provided by Section 39, Article III, Texas
- 20 Constitution. If this Act does not receive the vote necessary for
- 21 immediate effect, this Act takes effect September 1, 2021.
