1-17 A BILL TO BE ENTITLED
1-18 AN ACT

1-19 relating to the name of the statewide alert system for certain
1-20 missing adults.

1-21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 SECTION 1. This Act honors the victims of violence whose
1-23 lives and stories led to the passage into law of the CLEAR Alert for
1-24 Missing Adults: Cayley Mandadi, D'Lisa Kelley, Erin Castro, Ashanti
1-25 Billie, and the rest.

1-26 SECTION 2. The heading to Subchapter Q, Chapter 411,
1-27 Government Code, as added by Chapter 227 (H.B. 1769), Acts of the
1-28 86th Legislature, Regular Session, 2019, is amended to read as
1-29 follows:

1-30 SUBCHAPTER Q. COORDINATED LAW ENFORCEMENT ADULT RESCUE (CLEAR)
1-31 ALERT FOR MISSING ADULTS

1-32 SECTION 3. Section 411.461(2), Government Code, as added by
1-33 Chapter 227 (H.B. 1769), Acts of the 86th Legislature, Regular
1-34 Session, 2019, is amended to read as follows:

1-35 (2) "Alert" means the statewide Coordinated Law
1-36 Enforcement Adult Rescue (CLEAR) alert for missing adults that is
1-37 developed and implemented under this subchapter.

1-38 SECTION 4. The heading to Section 411.462, Government Code,
1-39 as added by Chapter 227 (H.B. 1769), Acts of the 86th Legislature,
1-40 Regular Session, 2019, is amended to read as follows:

1-41 Sec. 411.462. COORDINATED LAW ENFORCEMENT ADULT RESCUE
1-42 (CLEAR) ALERT FOR MISSING ADULTS.

1-43 SECTION 5. This Act takes effect immediately if it receives
1-44 a vote of two-thirds of all the members elected to each house, as
1-45 provided by Section 39, Article III, Texas Constitution. If this
1-46 Act does not receive the vote necessary for immediate effect, this
1-47 Act takes effect September 1, 2021.
