| 5 | SECTION 1. Subchapter A, Chapter 551, Government Code, is |

Except as otherwise provided by law, the recording shall 4 5 be made available to the public not later than 24 hours after the adjourning of the meeting. 6 7 SECTION 2. The heading to Section 551.023, Government Code, 8 is amended to read as follows: 9 Sec. 551.023. RECORDING OR LIVESTREAMING OF MEETING BY 10 PERSON IN ATTENDANCE. SECTION 3. Section 551.023(a), Government Code, is amended 11 12 to read as follows: A person in attendance <u>at an open meeting of a</u> 13 (a) 14 governmental body may: 15 (1) record all or any part of the [an open] meeting [of a governmental body] by means of a recorder, video camera, or other 16 17 means of aural or visual reproduction; or (2) stream live video and audio of all or any part of 18 the meeting on the Internet, provided that such recording does not 19 cause a distraction or disturbance to the proceedings of the 20 meeting. 21 SECTION 4. Subchapter B, Chapter 551, Government Code, is 22 amended by adding Section 551.024 to read as follows: 23 24 Sec. 551.024. INTERNET BROADCAST AND ARCHIVE OF OPEN MEETINGS. (a) This section applies only to a governmental body 25 26 that is an agency within the executive or legislative branch of state government to which the total appropriation made in the 27

1 General Appropriations Act from general revenue for any fiscal year beginning on or after September 1, 2021, including any amount of 2 3 general revenue transferred to the governmental body under that Act for that fiscal year, is greater than \$10 million and for which the 4 5 bill pattern for the General Appropriations Act for the same fiscal year designates 100 or more full-time employees. 6 7 (b) A governmental body that becomes subject to this section under Subsection (a) for a fiscal year shall comply with this 8 section in each following fiscal year. 9 10 (c) A governmental body subject to this section shall broadcast over the Internet live video and audio of each open 11 12 meeting of the governmental body. The governmental body shall 13 provide access to the broadcast on the governmental body's Internet 14 website. 15 (d) Not later than the seventh day after the date an open meeting is broadcast under this section, the governmental body 16 17 shall make available through the governmental body's Internet website archived video and audio of the open meeting. 18 The 19 governmental body shall maintain the archived video and audio of the open meeting on the governmental body's Internet website until 20 the second anniversary of the date the archived video and audio was 21 22 first made available on the website. 23 (e) The governmental body shall provide on the governmental 24 body's Internet website the same notice of the open meeting that the governmental body is required to post under Subchapter C. The 25 26 notice must be posted on the governmental body's Internet website

10 an open meeting over the Internet. <u>A governmental body shall</u> broadcast an open meeting over the Internet, or shall hold an open 11 12 meeting by telephone conference or videoconference, if the physical location of the meeting is not accessible to members of the public 13 or is not large enough to accommodate all persons seeking to attend 14 the meeting in person, including if the location has reduced 15 capacity as the result of an emergency or urgent public necessity, 16 17 as described by Section 551.045(b).

Except as provided by Subsection (b-2), a governmental 18 (c) 19 body that broadcasts a meeting over the Internet shall establish an Internet site and provide free and open access for members of the 20 public to the broadcast from that site. The governmental body shall 21 provide on the Internet site the same notice of the meeting that the 22 governmental body is required to post under Subchapter C. 23 The 24 notice on the Internet must be posted within the time required for posting notice under Subchapter C. 25

26 SECTION 7. Section 551.024, Government Code, as added by 27 this Act, applies only to an open meeting held on or after September

2 SECTION 8. The changes in law made by this Act apply only to 3 a meeting of a governmental body held on or after the effective date 4 of this Act.

5 SECTION 9. This Act takes effect September 1, 2021.
