The governmental body shall 9 provide on the Internet site the same notice of the meeting that the 10 governmental body is required to post under Subchapter C. 11 The notice on the Internet must be posted within the time required for 12 posting notice under Subchapter C. 13

14 SECTION 4. The changes in law made by this Act apply only to 15 a meeting of a governmental body held on or after the effective date 16 of this Act.
