- 14 (8) a municipality with a population of less than

- 3 SECTION 2. To the extent of any conflict, this Act prevails
- 4 over another Act of the 87th Legislature, Regular Session, 2021,
- 5 relating to nonsubstantive additions to and corrections in enacted
- 6 codes.
- 7 SECTION 3. This Act takes effect September 1, 2021.
