4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Title 6, Civil Practice and Remedies Code, is
6	amended by adding Chapter 150E to read as follows:
7	CHAPTER 150E. CIVIL ACTIONS OR ARBITRATIONS INVOLVING
8	TRANSPORTATION NETWORK COMPANIES
9	Sec. 150E.001. DEFINITIONS. In this chapter, "digital
10	network," "personal vehicle," and "transportation network company"
11	have the meanings assigned by Section 2402.001, Occupations Code.
12	Sec. 150E.002. APPLICABILITY OF CHAPTER. This chapter
13	applies only to an action or arbitration proceeding in which:
14	(1) a transportation network company is a defendant;
15	(2) the claimant seeks recovery of damages for loss of
16	property, bodily injury, or death;
17	(3) the claim for which the action or proceeding is
18	brought arises out of the ownership, use, operation, or possession
19	of a personal vehicle while the vehicle's driver or passenger was
20	logged on to a transportation network company's digital network;
21	and
22	(4) the theory of recovery for which damages are
23	sought against the transportation network company is based on:
24	(A) the ownership, operation, design,

1	manufacture, or maintenance of a digital network accessed by a
2	driver or passenger; or
3	(B) the affiliation or interaction with a driver
4	logged on to a transportation network company's digital network.
5	Sec. 150E.003. REQUIRED AFFIDAVITS. (a) Except as
6	provided by Subsection (b), at the time a claimant initially names a
7	transportation network company as a party in an action or
8	proceeding to which this chapter applies, a claimant shall, as
9	applicable, file with the petition or provide to the arbitration
10	tribunal and each other party at the initiation of the arbitration:
11	(1) an affidavit by the claimant's counsel that sets
12	forth specifically for each theory of recovery for which damages
13	<pre>are sought:</pre>
14	(A) the negligence, if any, or other action,
15	error, or omission of the company; and
16	(B) the factual basis for each claim; and
17	(2) an affidavit attesting that the damages suffered
18	by the claimant exceed the applicable insurance coverage limit
19	required under Chapter 1954, Insurance Code, that is signed by a
20	<pre>third-party expert who:</pre>
21	(A) is competent to testify; and
22	(B) offers testimony based on the expert's:
23	(i) knowledge;
24	(ii) skill;
25	(iii) experience;
26	(iv) education;
27	(v) training; and

1 (vi) practice.

- 2 (b) The contemporaneous filing requirement of Subsection 3 (a) does not apply to any action or arbitration proceeding in which the limitations period expires within 10 days of the date of filing 4 5 of the petition or initiation of arbitration and, because of the time constraints, a claimant has alleged that the required 6 affidavits could not be prepared. A claimant shall supplement the 7 8 pleadings with the affidavits not later than the 30th day after the date the petition is filed or the arbitration is initiated. The 9 trial court or arbitration tribunal may, on a motion by a party, 10 after hearing and for good cause, extend the deadline for 11 12 supplementing the pleadings as the court or tribunal determines 13 justice requires.
- 14 <u>(c) A defendant in the action or arbitration proceeding is</u>
 15 <u>not required to file an answer to the petition or arbitration</u>
 16 <u>request until the 30th day after the date all affidavits required by</u>
 17 Subsection (a) are filed.
- 18 <u>(d) This section may not be construed to extend any</u>
 19 applicable period of limitation or repose.
- Sec. 150E.004. DISMISSAL FOR FAILURE TO PROVIDE AFFIDAVITS.
- 21 (a) A court or arbitration tribunal shall dismiss with prejudice a
- 22 <u>complaint against a transportation network company with respect to</u>
- 23 which the claimant failed to file the affidavits in accordance with
- 24 Section 150E.003.
- 25 <u>(b) An order granting or denying a motion for dismissal</u> 26 <u>under this chapter is, as applicable:</u>
- 27 (1) immediately appealable as an interlocutory order;

- 1 <u>or</u>
- 2 (2) grounds to file an application to a court under
- 3 Subchapter D, Chapter 171, for the court to review the order.
- 4 Sec. 150E.005. LIMITATION OF LIABILITY. A transportation
- 5 network company may not be held vicariously liable for damages in an
- 6 action or arbitration proceeding to which this chapter applies if
- 7 the company:
- 8 (1) did not commit a crime under the laws of this state
- 9 or federal law; and
- 10 (2) has fulfilled all of the company's obligations
- 11 with respect to the transportation network company driver under
- 12 Chapter 2402, Occupations Code.
- SECTION 2. The changes in law made by this Act apply only to
- 14 a cause of action that accrues on or after the effective date of
- 15 this Act.
- SECTION 3. This Act takes effect September 1, 2021.
