A BILL TO BE ENTITLED

AN ACT

2 relating to the administration of public school assessment 3 instruments and the temporary suspension of certain accountability 4 determinations for public schools in a school year in which public 5 school operations are disrupted as a result of a declared disaster 6 and the requirement to use those assessment instruments as a 7 criterion for promotion or graduation of a public school student.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

9 SECTION 1. Subchapter B, Chapter 39, Education Code, is 10 amended by adding Section 39.0239 to read as follows:

11 Sec. 39.0239. ADMINISTRATION OF ASSESSMENT INSTRUMENTS AND 12 TEMPORARY SUSPENSION OF CERTAIN ACCOUNTABILITY MEASURES DURING DISASTER. (a) If, during a school year, a statewide disaster 13 14 declared by the president of the United States under the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 15 Section 5121 et seq.) or by the governor under Chapter 418, 16 Government Code, significantly disrupts school district 17 operations, including in-person attendance, in a majority of school 18 districts in this state, the commissioner shall apply to the United 19 States Department of Education for a waiver of the requirement 20 under the Every Student Succeeds Act (20 U.S.C. Section 6301 et 21 seq.) to administer assessment instruments during that school year. 22 23 (b) If the United States Department of Education fails to grant a waiver requested under Subsection (a), the assessment 24

No. 2802 1 instruments shall be administered as required under Section 39.023 2 during the applicable school year, but, notwithstanding any other law, the commissioner may not consider the results of the 3 assessment instruments for purposes of: 4 5 (1) evaluating school district or campus performance under this chapter for the applicable school year, including in 6 7 determining: 8 (A) the performance rating to assign to each district or campus under Section 39.054; or 9 10 (B) whether to impose any intervention or sanction authorized by Chapter 39A after the applicable school year 11 12 on each district or campus; or (2) determining a student's qualification 13 for 14 promotion or graduation. 15 SECTION 2. As soon as practicable after the effective date of this Act, the commissioner of education shall apply to the United 16 17 States Department of Education for a statewide waiver of the annual assessment of students required under the Every Student Succeeds 18 Act (20 U.S.C. Section 6301 et seq.) for the 2020-2021 school year. 19 SECTION 3. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 23 Act does not receive the vote necessary for immediate effect, this 24 Act takes effect September 1, 2021.
