- 6 adding Section 2265.002 to read as follows:
- 7 Sec. 2265.002. REQUIRED POSTING OF CERTAIN CONTRACTS. (a)
- 8 In this section, "governmental body" has the meaning assigned by
- 9 Section 552.003.

- 10 (b) Except as provided by Subsection (g), a governmental
- 11 body shall post on its Internet website each contract the
- 12 governmental body enters into for the purchase of goods or services
- 13 from a private vendor, including each contract entered into without
- 14 inviting, advertising for, or otherwise requiring competitive
- 15 bidding before selection of the contractor, along with:
- 16 (1) if the contract was not competitively bid, the
- 17 statutory or other authority that exempts the contract from
- 18 competitive bidding procedures; and
- 19 (2) if the contract was competitively bid, the request
- 20 for bids or proposals related to the contract.
- 21 (c) A governmental body shall post the contract and any
- 22 related documents required to be posted under Subsection (b) on its
- 23 Internet website:
- 24 (1) not later than the 14th day after the date the

- 1 contract is signed or otherwise adopted by the parties to the
- 2 contract; or
- 3 (2) if the contract is valued at less than \$15,000, not
- 4 later than the 30th day after the date the contract is signed or
- 5 otherwise adopted by the parties to the contract.
- 6 (d) The governmental body shall maintain the posting
- 7 required by Subsection (b) until the fourth anniversary of the date
- 8 the contract is completed or expires.
- 9 (e) A governmental body shall redact from a contract posted
- 10 on its Internet website under this section:
- 11 (1) information that is confidential under law;
- 12 (2) information the attorney general determines is
- 13 excepted from required public disclosure under Chapter 552; and
- 14 (3) the social security number of any individual.
- 15 (f) The redaction of information under Subsection (e) does
- 16 not exempt the information from the requirements of Section 552.021
- 17 or 552.221.
- 18 (g) A governmental body is not required to post the
- 19 information required by Subsection (b) for:
- 20 <u>(1) a contract required to be posted under Section</u>
- 21 <u>2261.253;</u>
- 22 (2) a memorandum of understanding, interagency
- 23 contract, interlocal agreement, or contract for which there is not
- 24 a cost; or
- 25 (3) any contract if the governmental body does not
- 26 maintain an Internet website.
- 27 SECTION 2. Not later than September 1, 2022, a governmental

- 1 body shall post to its Internet website each contract to which
- 2 Section 2265.002, Government Code, as added by this Act, applies
- 3 that was entered into before the effective date of this Act.
