- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 502.198(a), Transportation Code, is
- 7 amended to read as follows:
- 8 (a) Except as provided by Sections 502.058, 502.060,
- 9 502.1911, 502.192, 502.356, [and] 502.357, and 502.360 and
- 10 Subchapter H, this section applies to all fees collected by a county
- 11 assessor-collector under this chapter.
- 12 SECTION 2. Subchapter G, Chapter 502, Transportation Code,
- 13 is amended by adding Section 502.360 to read as follows:
- 14 Sec. 502.360. ADDITIONAL FEE FOR MOTOR VEHICLE FOR WHICH
- 15 REGISTRATION IS APPLIED FOR BY MOTOR VEHICLE DEALER. (a) In
- 16 addition to the applicable registration fee charged under this
- 17 chapter, an additional fee of \$25 per registration year is imposed
- 18 on the registration of a motor vehicle for which registration is
- 19 applied for under Section 501.0234.
- 20 (b) Notwithstanding any other law, an additional fee
- 21 authorized by a county under Subchapter H, including an additional
- 22 <u>fee authorized under Section 502.401, 502.402, or 502.403, may not</u>
- 23 be imposed on a motor vehicle described by Subsection (a).
- 24 (c) The fee imposed under this section shall be:

- 1 (1) collected for a motor vehicle when other fees
- 2 imposed under this chapter are collected; and
- 3 (2) deposited to the credit of the county road and
- 4 bridge fund of the county in which the owner of the motor vehicle
- 5 described by Subsection (a) is domiciled, provided that if the
- 6 county in which the owner of the motor vehicle described by
- 7 Subsection (a) is domiciled imposes an additional fee under
- 8 Subchapter H, an amount equal to the additional fee imposed under
- 9 that subchapter shall be deposited, remitted, and used, as
- 10 applicable, in accordance with the provisions of that subchapter
- 11 <u>authorizing the additional fee.</u>
- 12 (d) This subsection applies only to a motor vehicle for
- 13 which registration is applied for under Section 501.0234 in a
- 14 county other than the county in which the owner is domiciled. Each
- 15 Tuesday, a county assessor-collector shall send each fee imposed
- 16 under this section to the county in which the owner of the motor
- 17 vehicle described by this subsection is domiciled.
- 18 (e) This section does not apply to the renewal of
- 19 registration of a motor vehicle described by Subsection (a).
- 20 (f) The department may adopt rules to administer this
- 21 section.
- 22 SECTION 3. This Act takes effect September 1, 2021.
