- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6
- 7 SECTION 1. Sections 521.009(a), (a-1), and (c),
- Transportation Code, are amended to read as follows: 8
- 9 (a) The department may establish a program for the provision
- of renewal and duplicate driver's license, election identification 10
- certificate, and personal identification certificate services by 11
- 12 [in] counties, [and] municipalities, and private vendors that enter
- into an agreement with the department under Subsection (a-1). 13
- 14 (a-1) Under the program, the department may enter into an
- agreement with the commissioners court of a county, [or] the 15
- governing body of a municipality, or a private vendor to permit 16
- county, [er] municipal, or vendor employees to provide services at 17
- a county or municipal office or at a location determined by the 18
- vendor relating to the issuance of renewal and duplicate driver's 19
- licenses, election identification certificates, and personal 20

- 11 <u>vendor</u> must remit to the department for deposit as required by this

- SECTION 2. Section 521.428, Transportation Code, is amended
- 15 to read as follows:
- Sec. 521.428. COUNTY, [OR] MUNICIPAL, OR PRIVATE VENDOR
- 17 FEE. A county, [or] municipality, or private vendor that provides
- 18 services under an agreement described by Section 521.009 may
- 19 collect an additional fee of up to $\frac{$10}{$}$ [\$5] for each transaction
- 20 provided that relates to driver's license and personal
- 21 identification certificate services only.
- 22 SECTION 3. This Act takes effect September 1, 2021.
