underutilized businesses; and 1 2 (5) perform other duties as assigned by the 3 comptroller and presiding officer. 4 (c) The task force shall consist of: 5 (1) one historically underutilized business coordinator from each state agency with a biennial budget that 6 7 exceeds \$10 million, as described in Section 2161.062(e); (2) one member <u>appointed by the governor;</u> 8 9 (3) one member appointed by the lieutenant governor; 10 and 11 (4) one member appointed by the speaker of the house of 12 representatives. (d) Members of the task force that are appointed by the 13 14 governor, lieutenant governor, and speaker of the house serve 15 staggered terms of two years, with one or two members' terms expiring December 1 of each year. 16 17 (e) The member appointed by the governor shall serve as the initial presiding officer of the task force for a two-year term. 18 19 The task force shall elect succeeding presiding officers from among its membership at the first meeting following the expiration of the 20 presiding officer's term. 21 22 (f) The task force shall meet quarterly at the call of the presiding officer. 23 24 (g) Not later than December 1 of each year, the task force shall prepare and submit to the governor, the legislature, and each 25 26 state agency a written report summarizing the task force's findings and recommendations, including legislative recommendations. 27

1 SECTION 2. Not later than December 1, 2021, the governor, 2 lieutenant governor, and speaker of the house of representatives 3 shall each appoint one member to the historically underutilized 4 business task force as required under Section 2161.067, Government 5 Code, as added by this Act.

6 SECTION 3. Not later than December 1, 2021, the presiding 7 officer of the historically underutilized business task force 8 created under Section 2161.067, Government Code, as added by this 9 Act, shall call the first meeting of the task force.
