- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. The heading to Section 17.463, Business &
- 8 Commerce Code, is amended to read as follows:
- 9 Sec. 17.463. LIMITED AUTHORITY OF DISTRICT AND COUNTY
- 10 ATTORNEYS TO INVESTIGATE AND PROSECUTE CERTAIN DECEPTIVE ACTS OR
- 11 PRACTICES [PRODUCTION, SALE, DISTRIBUTION, OR PROMOTION OF CERTAIN
- 12 **SYNTHETIC SUBSTANCES**].
- SECTION 2. Section 17.463, Business & Commerce Code, is
- 14 amended by amending Subsections (a) and (f) and adding Subsection
- 15 (g) to read as follows:
- 16 (a) This section applies only to an act described by Section
- 17 17.46(b)(27) or (31) $[\frac{17.46(b)(31)}{31}]$.
- 18 (f) Notwithstanding any other law, in an action brought by a
- 19 district or county attorney under this section for a violation of
- 20 <u>Section 17.46(b)(31)</u>, all settlements or penalties collected by the
- 21 district or county attorney shall be divided between the state and
- 22 the county in which the attorney brought suit, with:
- 23 (1) 50 percent of the amount collected paid to the
- 24 comptroller for deposit to the credit of the basic civil legal

- 1 services account established by Section 51.943, Government Code;
- 2 and
- 3 (2) 50 percent of the amount collected paid to the
- 4 county shall be deposited by the county in a segregated account and
- 5 the funds shall be used only for law enforcement, public health
- 6 programs, or drug abuse prevention programs.
- 7 (g) Notwithstanding any other law, in an action brought by a
- 8 district or county attorney under this section for a violation of
- 9 Section 17.46(b)(27), all settlements or penalties collected by the
- 10 district or county attorney shall be divided between the state and
- 11 the county in which the attorney brought suit, with:
- 12 (1) 50 percent of the amount collected paid to the
- 13 comptroller for deposit to the credit of the general revenue fund;
- 14 and
- 15 (2) 50 percent of the amount collected paid to the
- 16 county.
- 17 SECTION 3. The changes in law made by this Act apply only to
- 18 an act or practice that occurs on or after the effective date of
- 19 this Act. An act or practice that occurs before the effective date
- 20 of this Act is governed by the law in effect on the date the act or
- 21 practice occurred, and the former law is continued in effect for
- 22 that purpose.
- 23 SECTION 4. This Act takes effect September 1, 2021.
