- 2 relating to charitable raffles conducted by the professional sports
- 3 teams charitable foundations of organizations sanctioned by
- 4 certain professional associations at rodeo venues.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 2004.002, Occupations Code, is amended
- 7 by amending Subdivision (2) and adding Subdivisions (5) and (6) to
- 8 read as follows:
- 9 (2) "Professional sports team" means:
- 10 (A) a team organized in this state that is a
- 11 member of Major League Baseball, the National Basketball
- 12 Association, the National Hockey League, the National Football
- 13 League, Major League Soccer, the American Hockey League, the East
- 14 Coast Hockey League, the American Association of Independent
- 15 Professional Baseball, the Atlantic League of Professional
- 16 Baseball, Minor League Baseball, the National Basketball
- 17 Association Development League, the National Women's Soccer
- 18 League, the Major Arena Soccer League, the United Soccer League, or
- 19 the Women's National Basketball Association;
- 20 (B) a person hosting a motorsports racing team
- 21 event sanctioned by the National Association for Stock Car Auto
- 22 Racing (NASCAR), INDYCar, or another nationally recognized
- 23 motorsports racing association at a venue in this state with a
- 24 permanent seating capacity of not less than 75,000; [ex]

- 1 (C) an organization hosting a Professional Golf
- 2 Association event; or
- 3 (D) an organization sanctioned by the
- 4 Professional Rodeo Cowboys Association or the Women's Professional
- 5 Rodeo Association.
- 6 (5) "Rodeo event" means a rodeo conducted at a rodeo
- 7 venue.
- 8 (6) "Rodeo venue" means a facility owned or operated
- 9 by and operated as the home venue of an organization sanctioned by
- 10 the Professional Rodeo Cowboys Association or the Women's
- 11 Professional Rodeo Association at which rodeos are conducted by
- 12 that organization.
- 13 SECTION 2. Section 2004.003, Occupations Code, is amended
- 14 to read as follows:
- 15 Sec. 2004.003. QUALIFICATIONS TO CONDUCT RAFFLE. A
- 16 professional sports team charitable foundation is qualified to
- 17 conduct charitable raffles under this chapter if the foundation:
- 18 (1) is associated with a professional sports team with
- 19 a home venue or rodeo venue located in this state;
- 20 (2) does not distribute any of its income to its
- 21 members, officers, or governing body, other than as reasonable
- 22 compensation for services;
- 23 (3) has existed for at least the three years preceding
- 24 the conduct of a raffle under this chapter;
- 25 (4) does not devote a substantial part of its
- 26 activities to attempting to influence legislation and does not
- 27 participate or intervene in any political campaign on behalf of any

- 1 candidate for public office in any manner, including by publishing
- 2 or distributing statements or making campaign contributions;
- 3 (5) qualifies for and has obtained an exemption from
- 4 federal income tax from the Internal Revenue Service as a
- 5 charitable organization described in Section 501(c)(3), Internal
- 6 Revenue Code of 1986; and
- 7 (6) does not have or recognize any local chapter,
- 8 affiliate, unit, or subsidiary organization in this state.
- 9 SECTION 3. Section 2004.004(a), Occupations Code, is
- 10 amended to read as follows:
- 11 (a) A professional sports team charitable foundation that
- 12 meets the qualifications under Section 2004.003 may conduct a
- 13 charitable raffle during each preseason, regular season, and
- 14 postseason game hosted at the home venue or each rodeo event at the
- 15 <u>rodeo venue</u> of the professional sports team associated with the
- 16 foundation to provide revenue for the foundation's charitable
- 17 purposes.
- 18 SECTION 4. This Act takes effect on December 1, 2021, but
- 19 only if the constitutional amendment proposed by the 87th
- 20 Legislature, Regular Session, 2021, authorizing the professional
- 21 sports team charitable foundations of organizations sanctioned by
- 22 the Professional Rodeo Cowboys Association or the Women's
- 23 Professional Rodeo Association to conduct charitable raffles at
- 24 rodeo venues is approved by the voters. If that amendment is not
- 25 approved by the voters, this Act has no effect.
