## A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to a governmental body's response to a request for public
- 3 information.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 552.221, Government Code, is amended by
- 6 adding Subsections (f) and (g) to read as follows:
- 7 (f) If the governmental body determines it has no
- 8 information responsive to a request for information, the officer
- 9 for public information shall notify the requestor in writing not
- 10 later than the 10th business day after the date the request is
- 11 received.
- 12 (g) If a governmental body determines the requested
- 13 information is subject to a previous determination that permits or
- 14 requires the governmental body to withhold the requested
- 15 information, the officer for public information shall, not later
- 16 than the 10th business day after the date the request is received:
- 17 <u>(1) notify the requestor in writing that the</u>
- 18 information is being withheld; and
- 19 (2) identify in the notice the specific previous
- 20 <u>determination the governmental body is relying on to withhold the</u>
- 21 requested information.
- SECTION 2. Section 552.301(b), Government Code, is amended
- 23 to read as follows:
- 24 (b) The governmental body must ask for the attorney

- 1 general's decision and state the specific exceptions that apply
- 2 within a reasonable time but not later than the 10th business day
- 3 after the date of receiving the written request.
- 4 SECTION 3. The heading to Subchapter H, Chapter 552,
- 5 Government Code, is amended to read as follows:
- 6 SUBCHAPTER H. CIVIL ENFORCEMENT; COMPLAINT
- 7 SECTION 4. Subchapter H, Chapter 552, Government Code, is
- 8 amended by adding Section 552.328 to read as follows:
- 9 Sec. 552.328. FAILURE TO RESPOND TO REQUESTOR. (a) If a
- 10 governmental body fails to respond to a requestor as required by
- 11 <u>Section 552.221</u>, the requestor may send a written complaint to the
- 12 attorney general.
- 13 (b) The complaint must include:
- 14 (1) the original request for information; and
- 15 (2) any correspondence received from the governmental
- 16 body in response to the request.
- 17 (c) If the attorney general determines the governmental
- 18 body improperly failed to comply with Section 552.221 in connection
- 19 with a request for which a complaint is made under this section:
- 20 (1) the attorney general shall notify the governmental
- 21 body in writing and require the governmental body to complete open
- 22 records training not later than six months after receiving the
- 23 <u>notification;</u>
- 24 (2) the governmental body may not assess costs to the
- 25 requestor for producing information in response to the request; and
- 26 (3) if the governmental body seeks to withhold
- 27 information in response to the request, the governmental body must:

- 1 (A) request an attorney general decision under
- 2 Section 552.301 not later than the fifth business day after the date
- 3 the governmental body receives the notification under Subdivision
- 4 (1); and
- 5 (B) release the requested information unless
- 6 there is a compelling reason to withhold the information.
- 7 SECTION 5. The changes in law made by this Act apply only to
- 8 a request for information that is received by a governmental body or
- 9 an officer for public information on or after the effective date of
- 10 this Act.
- 11 SECTION 6. This Act takes effect September 1, 2021.
