H.B. No. 3023

A BILL TO BE ENTITLED

1 AN ACT  
2 relating to the eligibility of the Professional Bull Riders World  
3 Finals for funding under the Major Events Reimbursement Program.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Sections 478.0001(3) and (7), Government Code,  
6 as effective April 1, 2021, are amended to read as follows:

7 (3) "Event" means any of the following and includes  
8 any activity related to or associated with the following:

9 (A) the Academy of Country Music Awards;

10 (B) the Amateur Athletic Union Junior Olympic  
11 Games;

12 (C) the Breeders' Cup World Championships;

13 (D) a game of the College Football Playoff or its  
14 successor;

15 (E) an Elite Rodeo Association World  
16 Championship;

17 (F) a Formula One automobile race;

18 (G) the largest event held each year at a sports  
19 entertainment venue in this state with a permanent seating  
20 capacity, including grandstand and premium seating, of at least  
21 125,000;

22 (H) the Major League Baseball All-Star Game;

23 (I) the Major League Soccer All-Star Game or the  
24 Major League Soccer Cup;

- 1 (J) a mixed martial arts championship;
- 2 (K) the Moto Grand Prix of the United States;
- 3 (L) the National Association for Stock Car Auto  
4 Racing (NASCAR):
- 5 (i) All-Star Race; or
- 6 (ii) season-ending Championship Race;
- 7 (M) the National Basketball Association All-Star  
8 Game;
- 9 (N) a National Collegiate Athletic Association  
10 Final Four tournament game;
- 11 (O) the National Collegiate Athletic Association  
12 men's or women's lacrosse championships;
- 13 (P) a national collegiate championship of an  
14 amateur sport sanctioned by the national governing body of the  
15 sport that is recognized by the United States Olympic Committee;
- 16 (Q) the National Cutting Horse Association  
17 Triple Crown;
- 18 (R) the National Hockey League All-Star Game;
- 19 (S) a national political convention of the  
20 Republican National Committee or the Democratic National  
21 Committee;
- 22 (T) an Olympic activity, including a Junior or  
23 Senior activity, training program, or feeder program sanctioned by  
24 the United States Olympic Committee's Community Olympic  
25 Development Program;
- 26 (U) a presidential general election debate;
- 27 (V) the Professional Bull Riders World Finals;

9                   (7) "Site selection organization" means:  
10                   (A) the Academy of Country Music;  
11                   (B) the Amateur Athletic Union;  
12                   (C) the College Football Playoff Administration,  
13 LLC, or its successor;  
14                   (D) the Commission on Presidential Debates;  
15                   (E) the Democratic National Committee;  
16                   (F) Dorna Sports;  
17                   (G) the Elite Rodeo Association;  
18                   (H) ESPN or an affiliate;  
19                   (I) the Federation Internationale de Football  
20 Association (FIFA);  
21                   (J) the International World Games Association;  
22                   (K) Major League Baseball;  
23                   (L) Major League Soccer;  
24                   (M) the National Association for Stock Car Auto  
25 Racing (NASCAR);

8 (V) [~~(U)~~] the Ultimate Fighting Championship;

9 (W) [~~(V)~~] the United States Golf Association;

10 (X) [~~(W)~~] the United States Olympic Committee;

11 or

12 (Y) [~~(X)~~] the national governing body of a sport

13 that is recognized by:

14 (i) the Federation Internationale de  
15 l'Automobile;

16 (ii) Formula One Management Limited;

17 (iii) the National Thoroughbred Racing  
18 Association; or

19 (iv) the United States Olympic Committee.

20 SECTION 2. To the extent of any conflict, this Act prevails  
21 over another Act of the 87th Legislature, Regular Session, 2021,  
22 relating to nonsubstantive additions to and corrections in enacted  
23 codes.

24 SECTION 3. This Act takes effect September 1, 2021.
