5	SECTION 1. Subtitle G, Title 8, Insurance Code, is amended
6	by adding Chapter 1511 to read as follows:
7	CHAPTER 1511. COVERAGE OF PREEXISTING CONDITIONS
8	Sec. 1511.001. DEFINITION. In this chapter, "prior
9	diagnosis of COVID-19" means a diagnosis of coronavirus disease
10	(COVID-19) or a related symptom or condition, present before the
11	effective date of an individual's coverage under a health benefit
12	plan.
13	Sec. 1511.002. APPLICABILITY OF CHAPTER. (a) This chapter
14	applies only to a health benefit plan that provides benefits for
15	medical or surgical expenses incurred as a result of a health
16	condition, accident, or sickness, including an individual, group,
17	blanket, or franchise insurance policy or insurance agreement, a
18	group hospital service contract, or an individual or group evidence
19	of coverage or similar coverage document that is offered by:
20	(1) an insurance company;
21	(2) a group hospital service corporation operating
22	under Chapter 842;
23	(3) a health maintenance organization operating under

EXCEPTIONS. This chapter does not apply to: (1) a plan that provides coverage: 20 21 (A) only for a specified disease or for another 22 limited benefit; 23 (B) only for accidental death or dismemberment; 24 (C) for wages or payments in lieu of wages for a period during which an employee is absent from work because of 25 26 sickness or injury; 27 (D) as a supplement to a liability insurance

3	(F) only for dental or vision care; or
4	(G) only for indemnity for hospital confinement;
5	(2) a Medicare supplemental policy as defined by

7	(3) a workers' compensation insurance policy;
8	(4) medical payment insurance coverage provided under
9	a motor vehicle insurance policy; or
10	(5) a long-term care insurance policy, including a
11	nursing home fixed indemnity policy, unless the commissioner
12	determines that the policy provides benefit coverage so
13	comprehensive that the policy is a health benefit plan as described
14	by Section 1511.002.
15	Sec. 1511.004. RESTRICTIONS BASED ON PRIOR DIAGNOSIS OF
16	COVID-19 PROHIBITED. Notwithstanding any other law, a health
17	benefit plan issuer may not:
18	(1) deny coverage to or refuse to enroll an individual
19	in a health benefit plan on the basis of a prior diagnosis of
20	COVID-19;
21	(2) limit or exclude coverage under the health benefit
22	plan for treatment related to the individual's prior diagnosis of
23	COVID-19 otherwise covered under the plan; or
24	(3) charge the individual more for coverage than the
25	health benefit plan issuer charges an individual who does not have a
26	prior diagnosis of COVID-19.
27	SECTION 2. If before implementing any provision of this Act

- 1 a state agency determines that a waiver or authorization from a
- 2 federal agency is necessary for implementation of that provision,
- 3 the agency affected by the provision shall request the waiver or
- 4 authorization and may delay implementing that provision until the
- 5 waiver or authorization is granted.
- 6 SECTION 3. The change in law made by this Act applies only
- 7 to a health benefit plan that is delivered, issued for delivery, or
- 8 renewed on or after January 1, 2022. A health benefit plan that is
- 9 delivered, issued for delivery, or renewed before January 1, 2022,
- 10 is governed by the law as it existed immediately before the
- 11 effective date of this Act, and that law is continued in effect for
- 12 that purpose.
- SECTION 4. This Act takes effect September 1, 2021.
