6	SECTION 1. Title 7, Government Code, is amended by adding
7	Chapter 793 to read as follows:
8	CHAPTER 793. IDENTIFICATION OF AND PROHIBITED COOPERATION WITH
9	CERTAIN UNCONSTITUTIONAL ACTS OF FEDERAL GOVERNMENT
10	Sec. 793.001. DEFINITIONS. In this chapter:
11	(1) "Political subdivision" has the meaning assigned
12	by Section 791.003.
13	(2) "State agency" has the meaning assigned by Section

15	Sec. 793.002. REVIEW OF EXECUTIVE ORDERS. (a) On the last
16	day of each month, the attorney general shall provide a written
17	report to the governor, lieutenant governor, speaker of the house
18	of representatives, and each member of the legislature that:
19	(1) identifies each rule adopted by a federal
20	government agency during the previous month that:
21	(A) relates to:
22	(i) pandemics or other health emergencies;
23	(ii) the regulation of natural resources,

1	(iii) the regulation of the agriculture
2	<pre>industry;</pre>
3	(iv) the use of land;
4	(v) the regulation of the financial sector
5	as it relates to environmental, social, or governance standards;

8	(vii) the free exercise of religion,
9	including the congregating of religious practitioners;
10	(B) was adopted in response to an executive order
11	by the president of the United States; and
12	(C) violates the rights guaranteed to the
13	citizens of the United States by the United States Constitution;

15	(2) provides the status of any lawsuit filed against
16	the federal government relating to a rule identified by any report
17	prepared under this section, including whether a court has found
18	the rule to violate the rights guaranteed to the citizens of the
19	United States by the United States Constitution.
20	(b) The attorney general shall publish any report prepared
21	under this section on the attorney general's website and in the
22	Texas Register.
23	Sec. 793.003. COOPERATION WITH UNCONSTITUTIONAL ACTS.
24	Notwithstanding any other law, a state agency or political
25	subdivision may not cooperate with a federal government agency in
26	implementing an agency rule that a report published under Section
27	793.002 indicates has been found by a federal court in a decision

- 1 that has not been stayed, reversed, or overruled to violate the
- 2 rights guaranteed to the citizens of the United States by the United
- 3 States Constitution.
- 4 Sec. 793.004. INJUNCTIVE RELIEF. The attorney general may
- 5 bring an action in a district court in Travis County or in a county
- 6 <u>in which the political subdivision is located to enjoin a violation</u>
- 7 <u>of Section 793.003.</u>
- 8 SECTION 2. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2021.
