A BILL TO BE ENTITLED 1 AN ACT 2 relating to health education requirements in public schools. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Section 28.025(b-1), Education Code, is amended 5 to read as follows: 6 (b-1) The State Board of Education by rule shall require 7 that the curriculum requirements for the foundation high school program under Subsection (a) include a requirement that students 8 9 successfully complete:

- (1) four credits in English language arts under Section 28.002(a)(1)(A), including one credit in English I, one credit in English III, one credit in English III, and one credit in an advanced English course authorized under Subsection (b-2);
- (2) three credits in mathematics under Section 28.002(a)(1)(B), including one credit in Algebra I, one credit in geometry, and one credit in any advanced mathematics course authorized under Subsection (b-2);
- (3) three credits in science under Section 28.002(a)(1)(C), including one credit in biology, one credit in any advanced science course authorized under Subsection (b-2), and one credit in integrated physics and chemistry or in an additional advanced science course authorized under Subsection (b-2);
- 23 (4) three credits in social studies under Section
- 24 28.002(a)(1)(D), including one credit in United States history, at

- 1 least one-half credit in government and at least one-half credit in
- 2 economics, and one credit in world geography or world history;
- 3 (5) except as provided under Subsections (b-12),
- 4 (b-13), and (b-14), two credits in the same language in a language
- 5 other than English under Section 28.002(a)(2)(A);
- 6 (6) four [five] elective credits;
- 7 (7) one credit in fine arts under Section
- 8 28.002(a)(2)(D); [and]
- 9 (8) except as provided by Subsection (b-11), one
- 10 credit in physical education under Section 28.002(a)(2)(C); and
- 11 (9) one credit in health under Section
- 12 28.002(a)(2)(B).
- SECTION 2. Section 28.025(b-1), Education Code, as amended
- 14 by this Act, applies only to students entering the ninth grade
- 15 during the 2021-2022 school year or a later school year. For
- 16 students entering a grade above ninth grade during the 2021-2022
- 17 school year, Section 28.025(b-1), Education Code, as that section
- 18 existed before amendment by this Act, applies, and that section is
- 19 continued in effect for that purpose.
- 20 SECTION 3. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2021.
