A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the registration of certain motor vehicles as farm or
- 3 ranch vehicles.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Section 502.433, Transportation
- 6 Code, is amended to read as follows:
- 7 Sec. 502.433. FEE: COMMERCIAL FARM OR RANCH MOTOR VEHICLE.
- 8 SECTION 2. Sections 502.433(a) and (d), Transportation
- 9 Code, are amended to read as follows:
- 10 (a) The registration fee for a commercial motor vehicle as a
- 11 farm vehicle or ranch vehicle is 50 percent of the applicable fee
- 12 under Section 502.252 or 502.253, as applicable, if the vehicle's
- 13 owner will use the vehicle for commercial purposes only to
- 14 transport:
- 15 (1) the person's own poultry, dairy, livestock,
- 16 livestock products, timber in its natural state, or farm products
- 17 to market or another place for sale or processing;
- 18 (2) laborers from their place of residence to the
- 19 owner's farm or ranch; or
- 20 (3) without charge, materials, tools, equipment, or
- 21 supplies from the place of purchase or storage to the owner's farm
- 22 or ranch exclusively for the owner's use or for use on the farm or
- 23 ranch.
- 24 (d) The department shall provide separate distinguishing

- 1 license plates for <u>farm and ranch vehicles</u> [a vehicle] registered
- 2 under this section. The department shall provide a person who
- 3 registers a vehicle under this section the option of designating
- 4 the vehicle as a farm vehicle or a ranch vehicle.
- 5 SECTION 3. Section 545.413(e), Transportation Code, is
- 6 amended to read as follows:
- 7 (e) It is a defense to prosecution under this section that:
- 8 (1) the person possesses a written statement from a
- 9 licensed physician stating that for a medical reason the person
- 10 should not wear a safety belt;
- 11 (2) the person presents to the court, not later than
- 12 the 10th day after the date of the offense, a statement from a
- 13 licensed physician stating that for a medical reason the person
- 14 should not wear a safety belt;
- 15 (3) the person is employed by the United States Postal
- 16 Service and performing a duty for that agency that requires the
- 17 operator to service postal boxes from a vehicle or that requires
- 18 frequent entry into and exit from a vehicle;
- 19 (4) the person is engaged in the actual delivery of
- 20 newspapers from a vehicle or is performing newspaper delivery
- 21 duties that require frequent entry into and exit from a vehicle;
- (5) the person is employed by a public or private
- 23 utility company and is engaged in the reading of meters or
- 24 performing a similar duty for that company requiring the operator
- 25 to frequently enter into and exit from a vehicle;
- 26 (6) the person is operating a commercial vehicle
- 27 registered as a farm or ranch vehicle under the provisions of

- 1 Section 502.433 that does not have a gross weight, registered
- 2 weight, or gross weight rating of 48,000 pounds or more; or
- 3 (7) the person is the operator of or a passenger in a
- 4 vehicle used exclusively to transport solid waste and performing
- 5 duties that require frequent entry into and exit from the vehicle.
- 6 SECTION 4. Section 622.074, Transportation Code, is amended
- 7 to read as follows:
- 8 Sec. 622.074. NONAPPLICABILITY OF SUBCHAPTER. This
- 9 subchapter does not apply to:
- 10 (1) farm equipment used for a purpose other than
- 11 construction;
- 12 (2) special mobile equipment owned by a dealer or
- 13 distributor;
- 14 (3) a vehicle used to propel special mobile equipment
- 15 that is registered as a farm or ranch vehicle under Section 502.433;
- 16 or
- 17 (4) equipment while being used by a commercial hauler
- 18 to transport special mobile equipment under hire of a person who
- 19 derives \$500 in gross receipts annually from a farming or ranching
- 20 enterprise.
- 21 SECTION 5. This Act takes effect September 1, 2021.
